## School voters OK tax increase, elect Yack, Stetz in low turnout

In a light turnout Monday, Plymouth-Canton voters passed a 1.5 mill increase for school operating expenses and elected Thomas Yack and Sylvia Stetz to the Board of Education.

A total of 6,080 voters cast ballots Monday which represents about 16 per cent of the approximately 38,000 voters in the school district.

Describing his reaction to passage of the 1.5 mill increase, Superintendent Mike Hoben said: "We're ecstatic." The district will be able to continue its quality programs, he added.

Passage of the 1.5 mill increase means restoration of a full-day of classes at elementary schools which were cut back by 45 minutes one day each week following a millage defeat last year and restoration of seventh and ninth grade athletic programs, the school board promised.

Official results showed that 3,302 voters were in favor of the millage and 2,628 voters opposed the six-year tax increase.

Voters in three of 14 precincts turned down the millage request. They were: Cen-

tral Middle, Isbister, and Starkweather schools. Voters casting absentee ballots also denied the millage bid by a vote of 144 to 105 votes.

In the 14-candidates race for two seats on the Plymouth-Canton Board of Education Yack, the only incumbent on the ballot, outpolled second-place winner Stetz by about 900 votes. Yack drew 2,581 votes to 1,696 for Stetz.

Earl Dean Swartzweiler talked third with 1,030 votes followed closely by James L. Sinclair with 1,008.

In fifth-place was Douglass Koch with 777 votes. Other candidates followed: Jeanette Wines with 750 votes; John C. Kim with 643; Gary Roberts with 472; Kenneth Vogras with 362; Linda Garrett with 354; Stephen Foley with 215; Kevin Campbell with 176; Allen Neil Smith with 122; and, Leroy Nelson, Sr. with 92 votes.

Calling his victory "gratifying and a vote of confidence," Yack added that the passage of the millage showed Plymouth-Canton residents support the school district.

Furthermore, he said he would like the

## Twp. to discuss charter status tomorrow night

Plymouth Township trustees have agreed to hold a special meeting tomorrow (Thursday) night when the sole topics of discussion will be adoption of a formal resolution on becoming a charter township, and two matters directly related to that step.

Supervisor Thomas Notebaert said he favors immediate passage of the charter resolution despite the specter of legal snags,

adding that he feels this is the sentiment of the full board. The meeting is scheduled for 7:30 p.m. in the Teledyne annex to Township Hall.

The proposed resolution had been on the board's June 5 agenda, but legal questions raised by Township Attorney Donald Morgan caused it to be tabled until an evening's total attention could be devoted to it.

Trustee Barbara Lynch, supported by Lee

Fidge, suggested the June 14 date for a special meeting and it was agreed to unanimously. The board also had been unanimous when it declared its intent March 29 to change from general law to charter status unless blocked by petitions for a referendum. Such petitions never materialized.

Thursday's agenda includes only these items: (1) Resolution on becoming a charter township; (2) Solid waste disposal ordinance;

(3) Budget for balance of calendar year -- charter township.

The latter essentially is a measure putting the township on a Jan. 1 -- Dec. 31 fiscal year basis as required in the state law pertaining to charter townships. The township's fiscal year now starts April 1.

The law also required that a uniform waste disposal collection service be established.

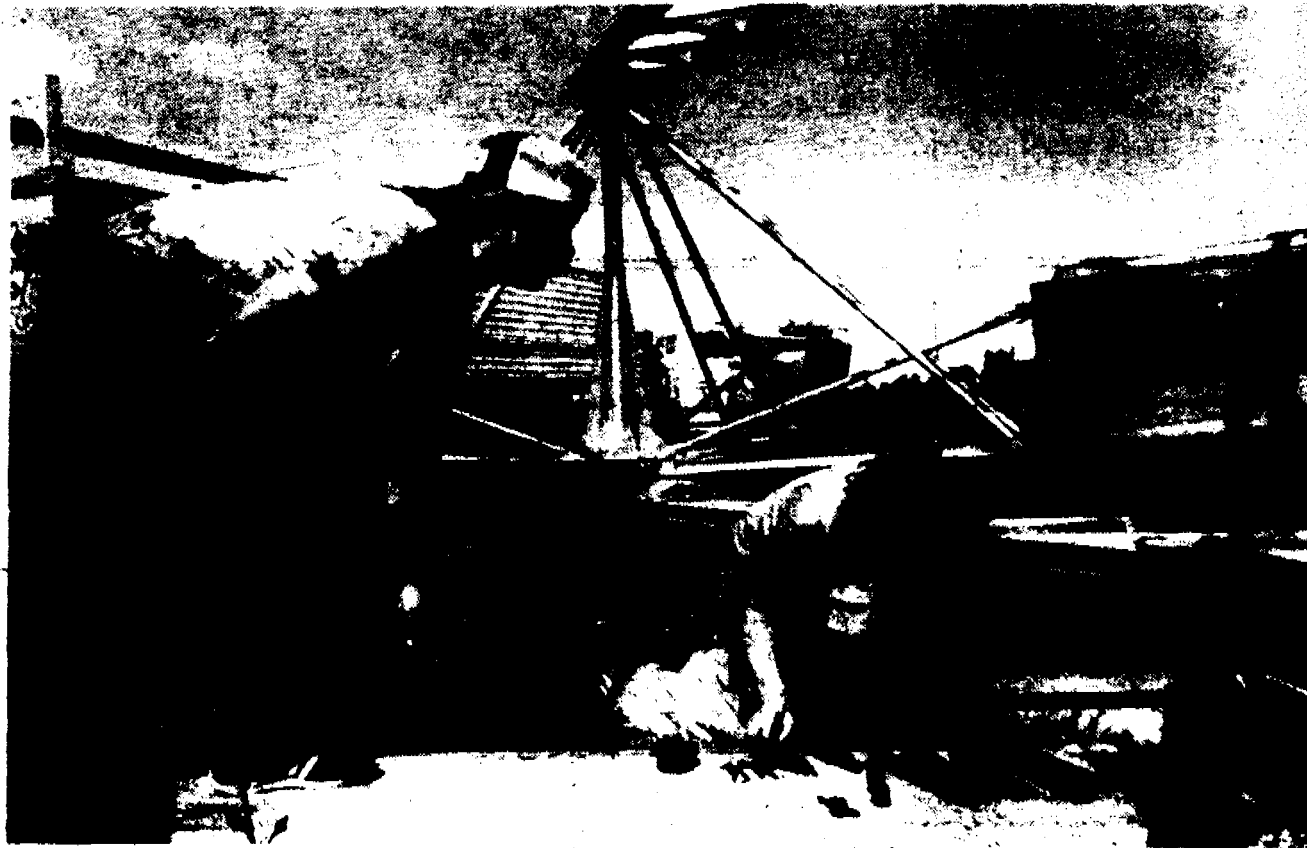
The big questions in Canton this week is: who will replace Trustee Lynne Goldsmith, who officially resigned from the board of trustees last Wednesday.

Rumors have been circulating and there has been a lot of speculation as to who will be appointed to fill the vacant seat on the board, said Supervisor Noel Culbert. So far Culbert has received six resumes from interested residents, however he said anyone could be appointed. He has received resumes from: Tom Stillings, Larry Bowerman, Mary Dingeldey, Dianne Neihengen, Doug Ritter, and Jerry Williams.

Goldsmith announced in April that she would resign in June or July to move to California. She has received criticism from fellow board members because she didn't resign immediately.

"I felt I still had something to contribute to the board," said Goldsmith in defending her position to remain on the board until she moved. She said it has opened up the field and given anyone who is interested a chance to know about the position and apply for it.

## Local man captures Schoolcraft board seat

Voters elected Michael Burley of Canton by 100 votes to serve a six-year term on the Schoolcraft Board of Trustees at the polls Monday. Also elected was Nancie Blatt of Livonia.

In other results, voters denied two, half-mill requests for Schoolcraft Community College at the polls.

Richard Hayward defeated Thomas Moore by 10 votes in his bid to serve a two-year term on the board. Unofficial results showed Hayward leading with 4,159 votes to Moore's 4,149.

In the race for two, six-year terms on the board, unofficial results were: Blatt tallied 5,541 votes; Burley had 4,595; Robert Ficano had 4,494; and, Gerald Cox totaled 4,353 votes.

In Proposal No. 1 for one-half mill for a culinary arts addition, Plymouth-Canton voters cast 2,014 "yes" votes and 3,554 "no" votes. The unofficial results showed a total of 5,568 voters in favor of the proposal and 9,122 voters opposed to it.

A one-half mill increase for improvement and maintenance programs at Schoolcraft was also defeated. A total of 6,313 voters favored the proposal and 8,442 voters were against it, according to unofficial results.

Plymouth-Canton voters reflected the trend by denying the request by 2,460 "yes" votes to 3,149 "no" votes.

"I don't know what the Board of Trustees will do now," said Dave Heinzman, director of college relations following the defeat. He said the college has \$1.2 million of the

projected \$2.2 million needed for the culinary arts building.

"The college needs to replace boilers, repair roofs, and maintain buildings," he added. He said the Board of Trustees would "study and evaluate" the situation in future meetings.

Monday's defeat at the polls marks the fifth time Schoolcraft College voters have denied millage bids since 1971, Heinzman said.

The unofficial results of Monday's election will be examined by the Board of Canvassers on Thursday night.

## Campaigners don't toe line

Where do you draw the line?

That question, among Plymouth-Canton school election precinct workers seems to be unsettled.

State election laws ban campaigning from within 100 feet of the entrances to buildings with voting precincts. Local school maintenance workers place a chalk white line at the 100 foot mark before the polls open each election day.

Yet, at Farrand Elementary School Monday morning, campaign workers were standing closer than the marked line to distribute literature and trinkets.

Marilyn Nitchman, precinct chairman at

Farrand, when questioned about the situation, asked, "Who put that white line there?"

She said she was unsure whether candidates campaigning at Farrand, Plymouth-Canton School Board President Tom Yack, said he had been told by election workers he could pass out fliers outside the school door. Election workers denied this. When a Crier photographer attempted to take a picture of Yack's poster-laden car parked inside the 100-foot mark, he moved his car, but continued to campaign inside the 100-foot mark.

School election officials said they were unsure whether the 100-foot law pertained to cars with election posters but said precinct workers are instructed to prohibit campaigning within the 100-foot line.

# Plan comish nixes sludge plant, housing project

A subsidized-income apartment complex site plan and a sludge plant special land use request have been denied by the Canton Planning Commission.

The denial recommendations were decided last Monday night at the Planning Commission meeting and will now go to the Canton Township Board of Trustees. The board could still approve the plans despite the planning commission's recommendations.

Bi-Products, Inc. proposed sludge processing plant site plan was tabled after the board decided by unanimous decision to recommend denial of the special land use request sought by the plant.

The board's decision was based on letters from Township Engineer Bob Wade and Township Planner Jim Kosteva.

Kosteva said that the Planning Department recommends denial "Because the compost operation is not compatible with adjacent property and neighborhoods," and that the "proposed process will adversely affect the community as a whole in two areas, odor and traffic."

Kosteva also said that "the land use suggested would be inconsistent and would not promote the intentions and purposes of the zoning ordinance."

Wade pointed to the original site plan as being "far superior" to the revised plan and said that "certain oversights or omissions in the revised plan, such as the lack of mixing pads, were essential to the plan's review."

He cited storm water storage and increased operating costs along with several other site plan considerations as weaknesses in the plan.

Mrs. Lynn LaBell, a representative of Canton's Stop Trucking In Noxious K-Contaminants Committee, presented the board with two separate petitions protesting the plant. The petitions totaled over 4,300 signatures.

"The impact of sewer sludge and noxious chemicals on our community can never be fully realized," one concerned citizen said, "and the number of deaths and diseases

## Is Canton board stacking ZBA by adding members?

The Canton Board will soon consider a proposal to expand its Zoning Board of Appeals to seven members from five.

Critics of the move say the intent is to load the ZBA with members favorable to the township board, which has been feuding with the ZBA.

Last week, the Canton Planning Commission, at the May 22 direction of the township board, considered an Interim Zoning Ordinance. After a half dozen split 3-3 votes, the planners voted to forward the ordinance to the Wayne County Planning Commission without a recommendation for approval or denial. Included in the ordinance is a change in the ZBA from five to seven members.

The ordinance should come back to the board from the county by late next week.

State law allows a community to have a seven-member zoning appeals board, but the township board has never officially voted in favor of such a change.

Township Treasurer Jim Donahue, who told the township's planning consultants to make the change while writing the interim ordinances, said four of the township board members had talked about the change.

"Doug (Calbert) and I, and Carol (Bodenmiller) and Bob (Groenastin) and I had talked about it," Donahue said.

The township treasurer denied the change was an attempt to stack the ZBA.

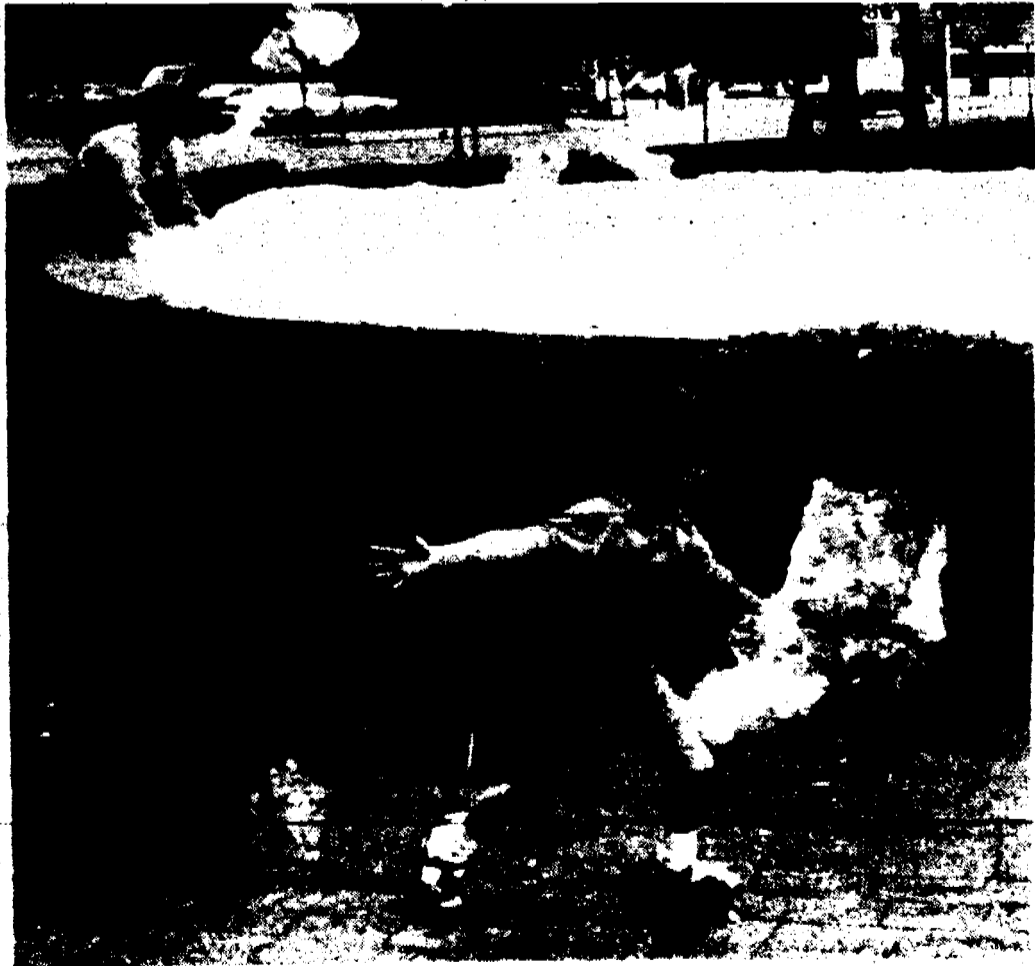
"I think the board was stacked against us to begin with, and I think we can make it more representative," Donahue said.

Gary Sands, chairman of the ZBA, countered, "That kind of depends on how you define 'us'."

He said he "suspects" the proposed change in the ZBA size is being considered "for much the same reason Roosevelt was interested in increasing the size of the Supreme Court."

"If the board thinks a broader represen-

Will it back down?  
**Ministrelli gets Twp. sewer bid it doesn't want**

Ministrelli Construction Co. of Novi has until June 18 to decide what course of action it will take after being awarded a six-mile Plymouth Township sanitary sewer job it doesn't want.

Although the firm was low bidder on the job by a wide margin, Ministrelli claimed an error of computation of more than \$1 million had been made and asked permission to withdraw the bid which amounted to slightly more than \$1.7 million.

Last Friday, the Wayne County Department of Public Works denied the withdrawal request, leaving Ministrelli in a position of having to decide whether to do the work for a price it claims was a mistake, forfeit the job and the bond bid of \$85,000, or start legal action against the township and county.

Standing in the wings is the Lanzo Construc-

tion co. whose bid of \$2.2 million was next lowest among the eight submitted. Township Supervisor Thomas Notebaert said he assumes that if Ministrelli refuses the job, it will go to Lanzo.

Notebaert does not see the situation as one which will cause any delay in the long-discussed project which will extend sanitary sewer service in Plymouth Township west to Ridge Road, opening that area to development.

Opposition to the sewer extension was so strong at one point among residents of the area that they forced a referendum in which the project was voted down. However, developers with township land holdings went to court and won their battle there.

A spokesman for the township's firm of consulting engineers said recently that unless there is undue delay the new lines should be in full service by next spring.

**Schools, Canton to meet**

The Plymouth-Canton Board of Education will meet with the Canton Township Board of Trustees on Wednesday, June 20. The time and meeting place have not been set yet.

The joint meeting was approved by the school board at its workshop last Monday night. Topics to be discussed include; summer tax collection; a review of land sites owned by the school districts in Canton; and, the use of school buildings for activities.

**Canton sets procedures for low income projects**

With low income housing under attack in Canton, the township board of trustees adopted a new policy at last week's meeting.

Recommended by Terry Carroll, Canton grant coordinator, the policy lists five steps as guide lines for handling future low income housing requests.

In the first step the supervisor receives the A-95 Review Request from the Southeastern Michigan Council of Governments (SEMCOG). The request is forwarded to the board as an informal item and passed on to the supervisor's designated staff representative for analysis.

Step two -- the staff representative determines the department(s) that could be affected by the project in question and notifies the appropriate department heads.

Step three -- board members, staff representatives and department heads make recommendations to the supervisor within three days as to the contents of any comments which should be sent to SEMCOG.

Step four -- if the proposed project relates to subsidized, multiple housing, in addition to the above steps, the supervisor will notify all property owners within 300 feet of the proposed development.

Step five -- the supervisor will then place the A-95 review request on the agenda of the next regular township board meeting and will take into consideration the comments of citizens before responding to SEMCOG.

Homeowners in Forest Trails and Pickwick Subdivisions are up in arms over the low-income apartment complexes proposed for their areas.

Because of a Planned Unit Development (PUD) agreement, residents in Pickwick may have legal rights to fight the project in their area, says Canton Supervisor Noel Culbert.

Culbert wasn't as optimistic about the Forest Trails project, where construction has already begun. "I think the only way to stop that project is to reach an agreement between all the parties," he said.

The only other thing that could halt the project is that Amurcon Corp., who is doing the building did not receive permission from Plymouth Township before tapping into its water and sewer lines, he said.

In related developments, Plymouth Township has issued a notice of violation against Wayne County for allowing Amurcon's tap in.

According to Plymouth Township Supervisor Tom Notebaert, the matter is now in the hands of the township's attorney, Don Morgan. a court date has been set for later in June.

Notebaert said the township was ordered to put in the storm sewer and assume its maintenance, but the county says it controls it. "They claim responsibility but not maintenance," Notebaert lamented.

## Plymouth-Northville to talk about DeHoCo's future

A meeting among heads of Plymouth and Northville area governments has been proposed for Thursday, June 28 to discuss the state's plans for building a regional prison on the site of the former women's facilities at the Detroit House of Correction.

This was revealed this week by Plymouth Township Supervisor Thomas Notebaert after he and four of the Northville area of-

ficials had met with representatives of the state to talk prison plans.

The DeHoCo property straddles Five Mile Road west of Beck Road. Men's quarters, still in use, are on the south side of Five Mile in Plymouth Township. The now vacant women's cottages are on the north side in Northville Township.

A new women's facility near Ypsilanti replaced the need for such a women's prison on the DeHoCo grounds.

"The plan is to convert the present women's facilities to accommodate 320 prisoners as a temporary five to eight years use and then build a medium security facility for 550 men and remove the temporary buildings," Notebaert said in a memo to his Board of Trustees.

He said this information came from a meeting with Rudolph Stahlberg of the State Bureau of Correctional Facilities, Eric Berry of the Office of Intergovernmental Relations, and Robert Terry of the Department of Management and Budget.

In the same session were Northville Township's supervisor, clerk and police chief, and the City of Northville police chief.

Notebaert defined the June 28 proposed meeting as "informational" and said it was the area group's desire to include the full governing boards of the Cities of Plymouth and Northville and the Townships of Plymouth and Northville. Time and place of the discussion remain undetermined.

### Hot stuff in court

Things got pretty hot in the 35th District Court in Canton last Friday.

Not that the court process itself was anything unusual -- except for a large docket -- it was that with no air conditioning on the hot, muggy day, everybody was really sweating it out.

"The people were really uncomfortable," said District Court Judge James Garber, who even opened up his robes while sitting on the bench. "You get 60 to 65 people in there and it gets warm."

The courtroom, located in the basement of the Canton Township Hall, is not yet air conditioned although the township board has approved the purchase of a new compressor for the air conditioning system. Officials expect the compressor to be hooked up in the next week or so.

Field, Gallimore, Labister, and Miller school students will begin at 8:35 a.m. and be dismissed at 2:35 p.m. except on Wednesdays when they'll start at 9:20 a.m. students in kindergarten classes will attend from 8:35 to 11:15 a.m. or 12:05 to 2:35 p.m.

At Pioneer Middle School, students will begin classes at 7:40 a.m. and finish at 2 p.m.

Also beginning June 18, school board offices at 454 S. Harvey St. will be open from 7:30 a.m. to 4 p.m.

# Canton eyes dumping salary body

A legal opinion is being sought by Canton Board of Trustees in regards to disbanding the compensation commission.

The non-partisan commission meets every other year to set salaries for the supervisor, clerk, and treasurer.

At last week's Canton board meeting, Trustee Robert Greenstein lashed out at the commission for recommending that salaries of deputy administrators be deducted from that of the elected officials.

Even with the pay hikes recommended by the compensation commission, Greenstein said the supervisor, treasurer, and clerk don't make enough to have the deputies salaries deducted from their pay.

"With all the hours the treasurer puts in, who would you get to work for \$1.24 an hour?" he asked.

"When I read their report, I almost climbed the barn walls," said Greenstein. "Maybe the trustees should decide what the officers get paid," he suggested.

Mike Mack, chairman of the compensation commission said, "if the township is getting to the point where it needs deputies for the full-time officers, maybe it's time to look at restructuring the administration."

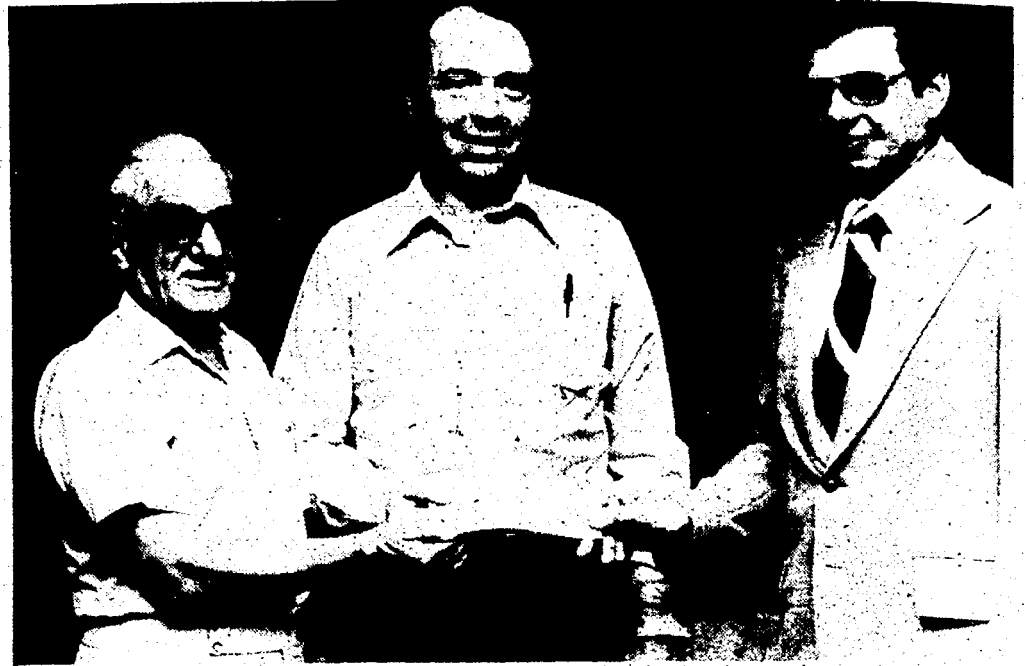
No one was able to demonstrate to the commission that the treasurer's job should be full time, said Mack. "Mike Gorman is the township finance director -- if we need more help, then we should hire in that department," he said.

Having a compensation commission, appointed by the board, takes the salaries of elected officials out of the political arena, Mack said.

The compensation commission recommended the supervisor's salary be increased from \$21,000 to \$28,000 over the next year and a half. According to the plan the clerk's salary would be increased from \$19,700 to \$24,000 during the same time schedule. The commission recommended the treasurer's salary be raised from \$7,500 to \$8,000 on Dec. 1, 1980.

Speaking out in favor of the compensation committee, Trustee Lynne Goldsmith said the commission was established by state law to get citizens involved in establishing officials salaries. "I'm not in favor of the board setting their own salaries," she said.

In a five to two vote, with Goldsmith and Trustee Gene Daley voting against the motion, the board decided to table the matter and seek advise of the township attorney.

## 4 expelled CEP students await court's decision

Four local students, expelled from the Centennial Educational Park after being charged with theft have asked to be considered under the Homes Youthful Trainee Act in court.

If accepted under the act, the youths could be placed under supervision of the court or be committed to state youth homes, according to Edward Zacharias, Wayne County court clerk.

Barre Joe Lee, David Florian Blendea, and Jimmy LaRiche appeared before Judge Thomas G. Smith of Wayne County Circuit Court on June 1. All three are 18 years old.

They had been charged with breaking and entering Salem High School and attempted larceny from a school building following

an incident on Feb. 16. On June 29, the three will appear before Judge Smith to see if they will be considered under the Homes Act.

The fourth youth, 19-year old Robert Gilson, appeared before Judge James Garber sitting in Circuit Court on June 8. Judge Garber will respond to Gilson's motion to be placed under the Homes Act on July 20. Gilson had been charged with possession of stolen credit cards, allegedly stolen from lockers in the Centennial Educational Park. LaRiche had also been charged with possession of stolen credit cards.

In May, the Plymouth-Canton Board of Education expelled all four students from the Centennial Educational Park following an investigation and subsequent charges by the Michigan State Police.

Plymouth Christian Academy on Joy Road received site plan approval for a new school at last Tuesday's Canton Township Board meeting.

According to Harry Guess, at the school, construction will begin soon, with a completion date set for sometime in the next academic school year. "We would like to move in during the Christmas holidays next year, but that will depend somewhat on the cement strike," said Guess.

# Pressure's on to solve water problems

It might take a \$1,400,000 project to improve the water pressure problems facing Canton residents.

According to Bob Wade of Wade, Trim and Associates, township engineers who described the million dollar project at last Tuesday's board meeting, "it is just one of the options we are looking into."

After discussing the water situation with the Detroit Water Board, Wade said it would be 1981 at the earliest, possibly 1982 or 1983 before the main extension line in Livonia was completed, which would give more pressure to Canton residents.

With construction of the Livonia line being held up, Canton officials are looking into the possibility of doing something on their own.

The million dollar project would involve running a water line from the Joy Road high pressure line south approximately two miles, without tapping into it along the way, said Wade. "It is the best option we have to work with on our own, without involving Detroit," he said.

Wade added that he hasn't given up on Detroit, "We need more assurances from them as to when the Livonia project will be finished, and if it will do the job, if we wait."

Low water pressure has already been experienced in some areas this year, said Jake Dingleday, DPW director. "We're conducting an investigation to see if any valves are closed," he said. "I don't know how we're going to get industry in if we can't provide water for fire protection," he added.

"We have authority to stop residents

from watering their lawns, but we don't have authority to stop contractors from building," said Robert Greenstein, township trustee.

The board asked Wade to put the project in writing and get a recommendation from Mike Gorman, finance director.

Water pressure problems surfaced later in the meeting, when the board gave final plat approval for Brentwood Estates Subdivision. A performance bond was requested advising builders and homeowners that they may not have water or sewers in their homes. "That notice will have to be put in the purchase agreement," said Township Treasurer Jim Donahue.

The board will discuss the water pressure problem at the June 26 meeting, after receiving Gorman's recommendation.

City residents who complained about the government during the past two years had their chance -- one more candidate in the race would statistically have had an 80% shot at winning.

It's too late to change the city race now, but there's at least a lesson to be learned for the future: serve!

Trifles such as a fractured shoulder and the necessity to keep one arm in a sling for several weeks will not deter Mrs. Leo Joseph McNamara from making it a memorable occasion when she and her husband host those who will be participating June 15 in the observance of Monsignor Edward J. Hickey's 60 years in the Catholic priesthood.

The McNamaras, who have close family bonds with the Hickey clan, have been planning this fete at their Penniman Avenue home in Plymouth for months. Less dedicated and devoted people might have let a bone-splitting fall such as Mrs. McNamara suffered last week ruin all that effort. Not the Irish.

There will be a commemorative Mass of Thanksgiving late in the afternoon in the gazebo on the grounds of the colorful McNamara residence. In addition to Msgr. Hickey, of course, the list of prelates who will be present reads like a who's who in the hierarchy of the Detroit archdiocese.

One of the highlights of the outdoor spectacle will be presentation to Msgr. Hickey of a framed parchment scroll bearing the papal blessing of Pope John-Paul II, signed personally by the pontiff and also bearing the Pope's picture.

Master of ceremonies for the occasion will be Rev. Edward Baldwin of Canton.

How does it happen that this celebration honoring the 85-year-old Msgr. Hickey is being held in Plymouth? Therein lies a tale, and its roots are in the fact that Msgr. Hickey, a wealthy man in his own right, is a noted art collector. By "noted," I mean, for instance, that his present collection is reportedly worth upwards of \$250,000.

Not that it's any of your business or mine, but he got his start in life by being born to a father and mother who owned the prestigious E. J. Hickey clothing firm on Washington Boulevard in downtown Detroit.

Mrs. McNamara fits into the script because she was his art gallery manager for 15 years.

The first 12 of those were on Seven Mile just off Livernois, but then came the memorable July Sunday of 1967 when the nation heard that "Detroit is burning."

The area at Seven and Livernois was among those torched in our civil strife. Msgr. Hickey and Mrs. McNamara, the latter having just moved to Plymouth from Dearborn, gathered their troops, loaded three vans with a fortune in art works, and drove west.

Then Ralph Lorenz came to the rescue. The Mayflower Hotel owner had taken over the Meeting House on Main Street only a short time before and the second floor,

now the ball room and banquet site, was vacant. Lorenz offered that spacious loft as a storing place for the works of art without charge and there they rested for about six months.

Meanwhile, a small white house only about a block away at the southeast corner of Ann Arbor Trail and Deer caught Msgr. Hickey's eye, and there his gallery was re-established as an attraction open to the public, although the Plymouth community may never have fully realized what was at its fingertips.

To get the house, Msgr. Hickey had to work out a financial rental deal with its owner, the late legal fox of Ann Arbor Trail, Earl Demel. Msgr. Hickey also spent about \$15,000 out of pocket to put it in shape. Then, after three years, Demel sold a nearby office building which he owned and, with City Hall's blessing, the deal included tearing the house down and converting it into a parking lot.

If you have a good enough nose for news, you can sniff enough between the lines of that paragraph to know why no municipal government representatives will be invited to join the celebration for Msgr. Hickey June 15.

Anyway, the good Father packed things up and went back to Detroit where he bought a three-story building at Grand Boulevard and Gratiot which remains the home of his art gallery to this day.

Msgr. Hickey has devoted his life and preachings to the Detroit area since he was ordained June 15, 1919 in the St. Peter and Paul Cathedral at Adelaide and John, in the heart of Detroit. However, he's possibly best known for the many years he served St. Mary's of Redford from which he retired in 1969 and where he now is pastor emeritus.

The noted Bishop Fulton J. Sheen has been invited to attend, having studied with Msgr. Hickey many years ago in Rome. Although it does not look as though the bishop can make it, Mrs. McNamara does expect the following to grace her home:

Msgrs. William Sherzer, Clement Kern and Stanley Fedewa, plus the Revs. Christopher Leahy, Edward Haggerty, Frances Byrne, Thomas Bresnahan, Ronald DeHondt, Kenneth MacKinnon, Russell Kohler, possibly Charles Coughlin, and definitely the MC, Father Baldwin.

I don't want to make light of this notable occasion, but at my house we've been the lawn party route before. Always the burning question has been whether or not it's going to rain. If Mrs. McNamara's impressive guest list can show me enough cloud upstairs to guarantee a sunny Friday afternoon, they may find themselves a convert.

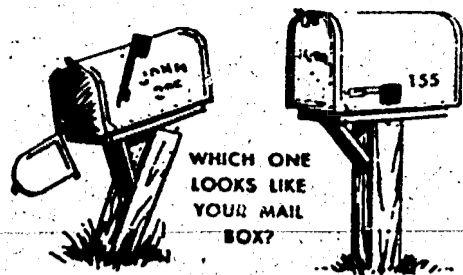

WAW WITH ALICE

In the eyes of the United States Post Office, you're not reading The Community Crier -- you're reading USPS 304150.

We wouldn't have known that ourselves save for an ugly letter we recently received for the Plymouth-Canton Post Office uncivil servants threatening us because we hadn't included that number in our "mail bug."

(Because The Crier uses a controlled circulation mail permit, we are required to print a "mail bug" in the first five pages of the paper containing certain information.)

The threatening letter we received said we should have been including the new number -- but we weren't aware we were required to do so.

It turns out that the original letter, informing us to use the number, was placed in the U.S. mail on Jan. 4. We're hoping it will arrive any day now.

We aren't surprised that we've been reduced to a number by the federal government which seems to be doing that to everything and everybody these days.

Nor were we surprised to receive an unfriendly communication from the Plymouth-Canton post office folks.

Postal law requires you to purchase, erect and maintain a mail box to certain specifications for the exclusive use of the U.S. Mail service.

Occasionally our paper carriers, to keep their customers papers dry or from being windblown, put the paper in somebody's mail box. (We instruct our carriers not to use the mailboxes, even though we think that law is ridiculous, and even call our carriers when we receive complaints from postal authorities.)

Recently, a power-tripping civil servant from the local post office called to threaten us with a bill for second-class postage on papers one carrier had placed in mail boxes. The call was not interested in correcting the situation, rather it was solely threatening. Our phone call to the person's superior has not been returned.

We could overlook the incident and classify it as simply another example of how the American postal system is eroding, were it not for another letter arriving from the post office.

This letter was notification that our rates were being raised again. (But at least the notification made it through the mails before the increase took effect.)

On top of the complaints we get about poor mail delivery of our papers' readers in Florida, Arizona and the outlying Plymouth-Canton hinterlands, this rate increase seems frustrating. (Newspaper handling by the post office is no different than regular mail. Plymouth's Pease Paint recently received a letter mailed from Livonia that was post-marked through New Orleans, La.)

If the postal system were a private business without constitutional protection from competition, it couldn't get away with this deteriorating service while raising prices and being uncivil on top of it. There's little we can all do except complain to our congressfolk.

But at least it would be more tolerable if the Plymouth-Canton Post Office workers were CIVIL servants.

Rules are made to be broken, or so it seems at Canton Township Board meetings.

The confusing thing is that Daley is one of the three board members who voted against smoking. I certainly don't understand the reasons behind his actions, however one would think that people making the rules in the township, would set a better example.

Another thing I don't understand is why the count of 40 people excludes board members and members of the press. Don't we count as people? We breathe the same air as everyone else in the room.

And I couldn't help but notice that the same smoking issue is back on the agenda for the next board meeting. I wonder if it has anything to do with the fact that non-smoking Trustee Lynne Goldsmith has recently resigned from the board. If you don't succeed the first time, try and try again. (Maybe the board will argue over appointing a smoker to Goldsmith's seat.)

Whether you smoke or not, is not the point. Once a ruling is passed or denied, uphold the decision.

PWP offers help

Fathers will be praised and presented with gifts this Sunday on Father's Day, however, most of them will testify that parenthood is not an easy task.

Subtract one parent from the family through divorce or death, and the second faces a new set of problems to be solved, according to Ernie Josefosky and Shirley Cameron, two single parents from Canton.

Ernie is the father of five children. But he feels like he is raising his first child now, although Glenn is actually his fifth. With divorce came responsibility for his two sons, Thom and Glenn, who are still at home. The responsibility is one he treasures, but it still meant adjustments. Re-arranging schedules was the first priority.

"Since I leave for work at 6 a.m., I wanted Thom, then a high school student, to make sure Glenn got off to school in the morning," said Ernie. That meant buying Thom a car so he could leave after Glenn. "Although it was a financial burden, I would have worried about Glenn at home alone," said Ernie whose hair is graying at the temples.

Do older kids resent assuming more responsibilities for younger siblings? Both Ernie and Shirley said no, adding that kids were very supportive. "As soon as kids get over the death or divorce, then it's easier," said Ernie. "Actually, the kids handled the divorce better than I did," he added.

Shirley said she visited her sons' teachers after their fathers' death, asking them to watch for changes in behavior. "If teachers are aware of changes in the family, then they can be sensitive to problems," she said.

Both Shirley and Ernie said their kids are more independent. Thom washes dishes and clothes and does other chores, said Ernie.

Shirley agreed, saying that her nine-year-old son Scott, vacuums, puts dishes

in the dishwasher, and makes simple meals. Freckle-faced Scott piped up later: "I even know how to make a casserole!"

Ernie called himself "a nervous wreck" following his divorce. Furthermore, he said listening to married persons talk about their spouses, and home lives hurt. "After 24 years of marriage, such chit-chat hurt," he added in soft tones. After his divorce, Ernie isolated himself for about one year.

Then he joined Parents Without Partners (PWP) about one and one-half years ago. "The first time you open the door to go to a meeting, it's tough," he recalled.

PWP provides both family and adult activities and, most importantly, it's a support group for persons facing the same situations, said Shirley. "With about 19 million single-parent households in the country, single parents are common," said Shirley. The week of August 12 to 19 will be proclaimed Parents Without Partners Week throughout the nation, said Shirley.

On being single, Shirley said: "I am alone, but not lonely." There's a difference.

"Now I have the best of both worlds. I am asked out to dinner, but don't have to pick up someone else's dirty socks or underwear," Shirley laughed.

Sometimes she admitted she missed not having a man around the house, "but my sons are there," she said. With the oldest sons, Michael and Stephen, married now, Shirley even trades babysitting chores with her daughter-in-law now.

At Shirley's household, past Father's Days have been celebrated when Scott, the youngest, presented the older son with a card made in school. "I'm convinced the older boys will be better fathers because of all the fathering they've done already," she laughed.

Last year's fair raised about \$4,000 for the Canton Jaycees. The 1979 goal is \$5,000, according to James Lane, fair chairperson. The money is used for various charitable projects in the community, such as the Ann Arbor Burn Center, donating Christmas baskets to community families, sponsoring the Easter Egg hunt for kids, and sponsoring the Haunted House at Halloween time for kids. Rock manager Brian Gilles hasn't had

much of a problem mustering up an offense this year, but his club's sixth and seventh inning rallies weren't enough.

Jim Anderson led off the sixth on first because of an error by the Adrian third baseman. Dave Wilcox lined a single to left and Merrill forced Anderson at third on a slow topper to the pitcher.

Etienne then pushed a wicked grounder to the first baseman's left, and the ball glanced off his glove. The scorer gave Etienne a hit, but the rightfielder overthrew the third baseman, allowing Wilcox to score the first run.

Hannan opened the seventh by grounding out to short. Paul Woodard legged out an infield hit and advanced to third when the Adrian catcher muffed a pickoff throw to first.

Paul Dillon worked a walk before Anderson pulled an inside pitch down the leftfield line for a long single, scoring Woodard. Wilcox and Merrill went down easily to end the season.

Gilles didn't have much praise for the Adrian team.

"Their pitcher was throwing strikes, but that's about all," he said. "He didn't have much on the ball."

"Etienne was getting the ball up. He might have been a little nervous, a little tight. We just battled back a little too late today."

tation is appropriate (for the ZBA), on the face of it, that's OK. But nobody's told me why this particular change is being considered," Sands said.

Sands said the board's apparent desire to create a seven-member ZBA they might take the opportunity to make seven appointments to the ZBA instead of adding two."

Bob Padgett, chairman of the Canton Planning Commission and a member of the ZBA, tried unsuccessfully to get the planning commission to eliminate the ZBA membership change and to recommend denial of the interim ordinances.

"It's certainly an attempt by the board to change the direction of some of the actions of the ZBA," Padgett said. "It's no secret that the board and the ZBA are at odds on many issues."

Padgett opposed the entire interim ordinance saying, "It's creating some dramatic changes. I'm not even sure some of the officials are aware of the changes."

"How can you do that and consider it to be defensible action is beyond me," the planning commission chairman said.

"The morality of it is wrong," he con-

tinued. "I don't care whether it's legal or not."

Padgett also lamented the absence of Planning Commissioner Bart Berg, who was hospitalized during last week's planning commission meeting when the six tie votes were recorded. "No doubt about it. I talked to Bart several times and he even offered to sign an affidavit or do whatever he could to get his vote counted."

The 3-3 votes saw Padgett, Bob Shefferly and Frank McMurray voting together with Carol Bodenmiller, Thom Carman and Dan Richardson on the opposite side. Berg generally would vote with the Padgett group.

Culbert said he thought the board would fill the vacancy in the next few weeks. "We have some important decisions ahead of us," he said.

The township board has 45 days to fill the remainder of the term, which expires in 1980. If they can't come to an agreement in that time, a special election will be held.

Four out of the six board members must agree on the selection of the new trustee.

Mrs. Goldsmith is leaving this week for California, where her husband Rev. Jeffery Goldsmith recently accepted a position as pastor of St. Stephen Presbyterian Church in Chatsworth.

caused by it will not be known until it is too late."

The proposed apartment complex, Independence Square, would border Pickwick subdivision on Lilley Road and residents in the subdivision fear increased crime and

lower property values would result from the low income housing.

Pickwick Homeowners Association President Tom Stillings told the board, "The low income housing is inherently incompatible with the \$80,000 to \$100,000 homes in Pick-

wick," and that the "residents are turning to the township for the protection of their homes and schools."

Stillings said, "Many residents were told by the real estate agents that luxury apartments were planned for the site."

But Kim Wilkens, of Amurcon, told the residents that "Conventional apartment financing is not economically feasible at this point in time."

The proposed complex would be financed with the help of an FHA mortgage guarantee and this guarantee requires the project provide low-income assistance.

"The occupancy goals set for a complex of this type are 45 percent low income; 45 percent low-low income; and the remainder to be rented at the current market value of \$347 to \$382 a month," Wilkens said.

Wilkens also denied allegations that Amurcon was ever involved in an occupancy permit forging scandal and pointed to Amurcon's \$55,000,000 bonded status as one basis for their credibility.

"We have eight other projects like this one in outstate areas and have never had one go sour," Wilkens said. "All our projects are covered by our bond and I will charter a bus to take your representatives to see some of these," Wilkens said.

But the eventual site plan denial did not come without sometimes-shouted and name-calling complaints of homeowners.

The denial recommendation is based on an abrogation of the Planned Unit Development contract (PUD).

"The contract calls for all multiple dwellings to be built in the area before single family housing.

Because they were not, the parcel of land zoned multiple dwelling after the PUD contract enactment must revert to its previous zoning -- single family housing," according to Planning Commission Chairman Robert Padgett.

But the final denial recommendation did not come easily. The three hours of open debate were followed by five separate board recommendations that failed to gain a majority.

The approved recommendation was actually the first one put forth by Commission Member Carol A. Bodenmiller but failed on the first time around.

The Bodenmiller recommendation was finally passed, when it was reconsidered an hour and a half later, by a five to one margin with Bart Berg voting against it.

Berg contended the commission had no legal grounds to consider the site plan on the basis of the PUD legal question.

Planning Commissioner Frank McMurray was absent.

This can be done by ordinance specifying conditions which private contractors must meet.

Police protection also is a "must" under charter law, but this matter is not being included for discussion Thursday.

A special election Sept. 11 will determine whether the township approves a millage levy going exclusively for police services. A contract with the Wayne County Sheriff's Department currently is under discussion.

Morgan's position that the law is vague as to what the township must specifically do

to adopt charter status simply by resolution, instead of through a general vote of the electorate, is the thorn which has led to the confusion.

His memo to trustees after the deadline for filing referendum petitions had passed referred to the State Legislature having made "a determined effort to frustrate the English language."

Morgan said the law "fails to specify what constitutes final passage of the resolution (to incorporate)." He made it plain, that in his opinion there would have been no such problem had voters approved the form of government change at the polls.

The attorney does not usually attend board sessions, but Notebaert said he has been asked to be present Thursday.

Notebaert, Clerk Esther Hulsing and others of the board have said they think the right position is to proceed with adoption of the resolution and then let Morgan research the legal ramifications after its passage, a course the attorney offered as an alternative to further delay.

"We've dillie-dallied long enough on this. Mr. Morgan can work out the legal problems afterwards," was Mrs. Hulsing's summation.

Behind the whole situation lies the township's fight to avoid annexation, all or in part, by the City of Plymouth, a fight that would possess far greater legal muscle as a charter government than is now available as a general law entity.

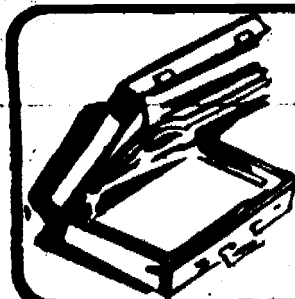

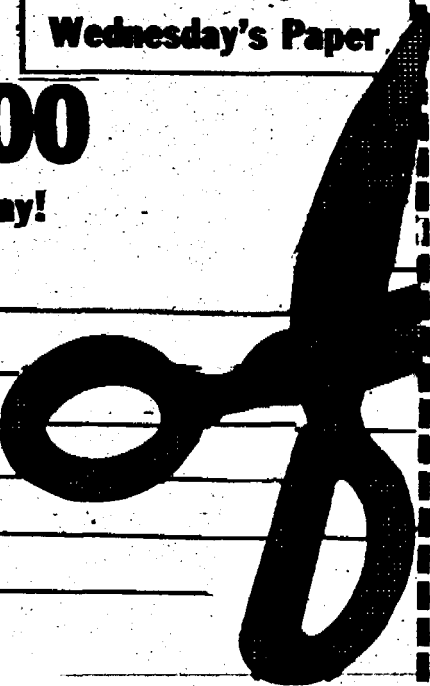

### TOWNSHIP OF PLYMOUTH BOARD OF TRUSTEES - REGULAR MEETING TUESDAY, JUNE 5, 1979

The meeting was called to order by Supervisor Notebaert at 7:30 p.m. followed by the Pledge of Allegiance. All members were present.

It was moved by West, supported by Fidge that the minutes of the Special Meeting of May 16, 1979 be approved as submitted. Ayes all except Hulsing who abstained.

Fidge moved, supported by Law that the minutes of the Regular Meeting of the Board of Trustees, May 22, 1979 be accepted as corrected, amended and added to. Ayes: Fidge, Law, Lynch, Notebaert and Breen. Nays: West and Hulsing.

Lynch moved to add as No. 6 under "Communications and Reports" as an oral report a discussion of the fire department's contract negotiations. Supported by Law that this item be added. Ayes all.

Lynch moved to add as Item No. 7 under the same division and oral report on the Teledyne Building. Supported by Fidge. Ayes all. It was requested that this item be on the agenda every time until completion. Supported by Fidge. Ayes all.

It was moved by Fidge, supported by Law to move item II-12 to the first item under Old Business. Ayes all.

It was moved by Fidge and supported by Law that Items II-8 and III-3 for which a closed session had been requested be moved to the position of last items to be considered. Ayes: Lynch, Fidge, Law, Hulsing, Breen, Notebaert. Nays: West.

It was moved by Lynch and supported by Fidge to approve the agenda as amended and rearranged. Ayes all.

The public hearing on the use of EP-10 funds and the proposed budget therefore was opened at 8:05 p.m. Questions were asked for: from the Trustees and Public. The Clerk explained the probable allocation. The Supervisor closed the hearing at 8:15 p.m.

It was moved by Fidge, supported by West that from the allocation to the Township of the EP-10 funds in the amount of \$98,755, \$20,000 be spent for a small pumper for the Fire Department, \$22,500 for the Domestic Assault Program (F Step), \$1,000 for a Safety Program for pre-schoolers, \$25,255 for Bike Paths, and \$30,000 for Storm Water Manager Plans. Breen abstained. All other voted aye.

William Gross, Vice-President of Pitometer, whose company has specialized in water distribution systems for over 25 years spoke to his report.

It was moved by Breen and supported by Fidge to table this report for adoption as a Master Plan for the Water System at the last meeting in June. It will be expected of consultants and employees that they follow the plan rigidly if it is adopted. Ayes all.

It was moved by Lynch, supported by Fidge that a special meeting be called for on Thursday, June 14, 1979 to consider the Charter Township Resolution and to adopt the budget and the solid waste disposal ordinance at that time. The attorney will be asked to be present. Ayes all.

It was moved by West and supported by Hulsing that the request of C. A. McClumpha that the \$625.00 paid to Plymouth Township with an application for rezoning which the Township did not use be used as follows: \$300.00 be applied on the fee for a conditional use permit, \$35.00 be applied to the Board of Appeals for an application for a variance and a refund of \$290.00 be granted. Ayes: West, Hulsing, Notebaert. Nays: Lynch, Fidge, Breen and Law.

It was moved by West and supported by Hulsing that an amendment to the Group Pension Plan permitting retirement at age 55 be requested of Manulife. Ayes: West, Hulsing, Notebaert. Nays: Lynch, Fidge, Breen, and Law.

It was moved by Breen, supported by Fidge that \$108.00 be transferred from Contingency 941 to the Employee Bond Account 954-911. Ayes all.

It was moved by Fidge and supported by Breen that the Clerk be requested to Write all consultants instructing them that when Trustees call with questions that they supply the information. Ayes: Notebaert, Law, Fidge, Lynch, Hulsing, Breen. Nays: West.

It was moved by Breen and supported by Fidge to solicit an invitational bid on the Attitudinal Survey along the lines of the one conducted by Brownstown Township with Law providing the specifications for bidding. Ayes all.

It was moved by Breen, supported by Hulsing that the request of Rescom Development Corporation for an extension of time to September 1, 1979 for the completion of the open space improvements be granted. Ayes all.

It was moved by Hulsing, supported by West that the full backing of the Township Board be given the Plymouth Area Reaction Team to patrol the Township area with a proposed C.B. Mobile Unit according to the proposal submitted by Charles VanVliet and Paul Cook. Ayes all.

It was moved by Fidge and supported by Hulsing that the request of Mr. Hollis Water and Sewer Superintendent, to have General Government funds expended to improve the lot to the east of the Water and Sewer facility by Perlongo Excavating in the amount of \$3,705.00 be granted. Ayes: Breen. All the rest voted aye.

It was moved by Fidge and supported by West that a resolution in support of the Revenue Sharing Act as now administered be sent to members of the State Legislature and Congress. Ayes all on a roll call vote. A copy of the resolution is appended to the permanent minutes.

Moved by Hulsing and supported by Breen to pass a resolution in opposition to House Bill 4272 which would provide for tax payments made in six monthly requests before February 15th by the taxpayer. On a roll call vote -- ayes all. A copy of the resolution is affixed to the official minutes of this meeting.

It was moved by Fidge and supported by Hulsing that Lynch continue with her investigation of the cost of the porch on the Golf Club Building and bring back recommendations to the Board at the June 12, 1979 meeting. Ayes all.

It was moved by Hulsing and supported by Breen to close the meeting at 11:40 p.m. for the purpose of discussing personnel problems at the request of the employees. Ayes all.

Supervisor Notebaert reconvened to the open meeting at 12:25 a.m. It was moved by Hulsing and seconded by Lynch that seven days be credited to Mrs. Deanna's sick bank; vacation time now due her be taken during the current calendar; her anniversary date be moved back to September 1, 1977 and her salary reduced to \$12,300.00. Ayes all.

It was moved by Breen and supported by Fidge that a pay raise be granted Chief Groth at the time of the settlement of the firemen's contract retroactive to May 21, 1979. The pay raise will reflect a 10% differential between the top pay of a Sergeant's wage and the Chief's. Ayes all.

It was moved by Breen and seconded by Law that Chief Groth be given credit for eleven years of service with the Township of Plymouth and at this time be transferred to the annual leave schedule of fringe benefits for non-represented employees. He has now those weeks accrued for use in 1979. As of May 1, 1979 he will start accruing for 1980. Ayes all.

It was moved by Hulsing and seconded by West that since Groth was now terminating employment as a fireman which entitles him to pay-off on 60 days of accumulated sick time that we multiply those 60 days by a conversion factor of 2.16 (A conversion factor to change 24 hour shifts to 8 hour shifts) to give him 130 days. At his request we can transfer 60 of those days to his sick time bank and then pay him off on the balance of the 70 eight-hour days which amounts to \$3,696.00 (his current hourly rate as Sergeant x 70 days). Ayes all.

It was moved by Hulsing, seconded by Breen that Chief Groth receive a \$500.00 clothing allowance immediately and hereafter \$400.00 on January 1 of each year. Ayes all.

Moved by Lynch and seconded by Fidge that holidays, family sick days, personal business days, pension, hospitalization, life insurance and bereavement leave would be the same for Chief Groth as for other non-represented employees. Pay will not be received for overtime nor can compensatory time be accrued. An automobile will be provided for Fire Department Business. Ayes all.

Hulsing moved adjournment at 12:55 a.m. Seconded by Breen, Ayes all.

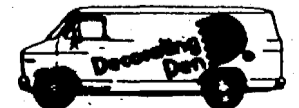

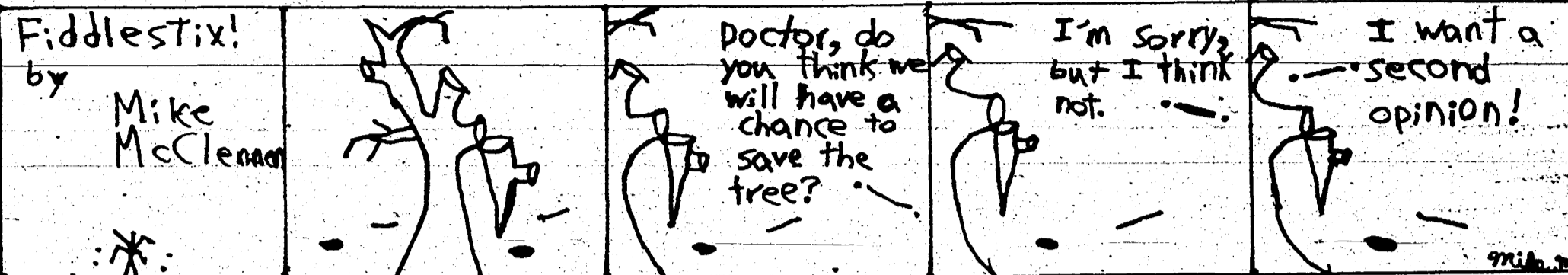

**PLYMOUTH-CANTON COMMUNITY SCHOOLS BOARD OF EDUCATION MINUTES**

Following is a synopsis of April and May meetings of the Board of Education of the Plymouth-Canton Community Schools. Complete minutes or further information on any subject may be obtained by calling the Board office at 454 S. Harvey Street, Plymouth, 4533-3100. (Note: All motions carried unanimously, unless otherwise noted.)

April 9, 1979: A premeeting was held to hear Grievance #78-79-14, after which the regular meeting was called to order at 8:20 p.m. Member Gray was not present at this meeting; agenda and previous minutes were approved. Citizens rose to discuss boundary changes proposed by administration: Dave Cifaldi (Forest Trails); See Scott (Mayfair Subdivision); Bob Clayton, (Forest Trails); and Sharon Bennett. Joan Campbell asked that the Board consider bus purchases over other priorities; Diane Neigegen asked the Board for information re: transfer of students from Eriksson to Hulsing Elementary and possible loss of Title I funding; and Peter Hason had a concern re: bus transportation for ESY students on Good Friday.

Mr. Hoben discussed the MAISL meeting to be held on April 12, and announced that, due to the ice storm, certain schools would be closed for two more days. The first meeting of the Citizens Election Committee was to be held on April 10.

Old Business: The matter of bus purchases for the coming school year was removed from the table -- to award the purchase of 10 sixty-six passenger buses and 3 twenty-three passenger buses, funds for which would come from 1979-80 General Operating Budget. It was noted that this minimum order is necessary to continue provision of adequate bus service and to avoid double-tripping. The motion was carried unanimously. The boundary and Growth Committee recommendations were considered by the Board, and the following changes adopted:

- From Gallimore to Hulsing -- Sunflower III, south of Warren and west of Canton Center.
- From Eriksson to Hulsing -- Quarter mile bounded by Canton Center, Ford, Sheldon, and Saltz Roads.
- From Field to Fiegel -- Brookside Village, east of I-275, south of Cherry Hill, west of Hanson, north of Churchill (including Churchill).
- From Field to Miller -- Foxborough Subdivision, east of Morton Taylor, south of Palmer.

Middle Schools: Continue ESY at Pioneer School, with other middle schools to remain on Traditional Schedule. Students from Windemere II, Sunflower III, Forest Trails, Mayfair and Hampton Court subdivisions to attend Central Middle School in 1979-80.

High Schools: Authorize administration to pursue minor renovations to both Canton and Salem High Schools to accommodate an overexpand student population.

New Business: Bills for payment were approved in the total amount of \$940,132.85. Maternity leave was granted to Mary Hendricks, Miller School; and retirement accepted for Kathryn Touhey, Eriksson School, after 12 years of service. A letter was approved addressed to PCEA Grievance Committee which would approve administrative reply to Grievance #78-79-13. No violation of the master agreement was found.

A motion was passed to delay until the next regular meeting a decision to consider a resolution regarding third-year probation for employee #001. A motion was then adopted which would adopt the date of Monday, June 11, 1979 as the School District's annual election. A policy was recommended by legal counsel and adopted which would allow executive sessions (closed) for the Board of Education for handling evaluation of employees. And finally, the Board found that, after hearing testimony for Grievance 78-79-14 from the PCEA, that the situation does not create a violation of the Master agreement.

Board members commended PTO's and schools in the District for information regarding bicycle safety and on tornado drills and storms. The Young Authors' program at Gallimore School was also commended. Meeting adjourned at 10:40 p.m.

April 16, 1979: A workshop was held to discuss Superintendent's evaluation, millage, and Board objectives, after which the Board adjourned to closed session to discuss preparations for negotiations. Member Gray did not attend this meeting.

April 23, 1979: Members Gray and Harper did not attend this meeting. As previously noted, all motions were carried unanimously unless otherwise noted. Agenda and minutes for previous meetings were approved. Announcements were made as follows: Auditing Committee for the Board for May/June would be Members Davis and Kirchgatter and Treasurer Harper; joint session with Citizens Bond Advisory Committee would be held on April 30; special meeting of Board will be held on May 7 to discuss expulsion proceedings and millage proposals. A workshop for Saturday, May 12, was announced to discuss negotiations, beginning at 9 a.m. In addition, a letter of resignation was read from Mr. Charles Heidt, Chairperson of the Citizens Bond Advisory Committee. His resignation was accepted with regret. Items from the agenda for Plymouth Township Board of Trustees were discussed, including an ordinance to require builders to provide accurate information to potential home buyers regarding where their children would attend school; and one which would ask that all units of Government within the School District participate financially in the District "Safety Town" program.

Administration Reports: The Superintendent discussed the Board's amendment formula, and summarized education laws enacted during 1978. Copies of these laws are available in the Superintendent's office. Other items discussed at the last meeting of MAISL were also considered including compensation for Board members for certain activities in addition to Board meetings; State Aid; and holding of tax collections by various units of Government, and the issue of the 21-month fiscal year of the State.

The Operating Budget Status Report was presented. Projected fund balance as of June 30, 1979, was estimated as \$516,126. The Capital Fund issue was also discussed. Kilowatt usage and gas consumption discussions were noted.

Old Business: Mrs. Alice Redwick and Mrs. Sue LaSota were appointed as new members of the Reproductive Health Committee.

New Business: Checks in the total amount of \$9,439,969.47 were approved for payment; attendance at the American Management Association Conference on Collective Bargaining in Houston was approved for Daniel White, Executive Director of Finance; and in addition, a divider wall purchase was approved for installation at Canton High School to provide more classroom space. Graduation exercises at both Salem and Canton High Schools were announced, and Board members were requested to attend. A special resolution to pay tribute to the many volunteers who contribute to the well-being of this School District in many ways was approved.

A Principal transfer between Smith Elementary and Eriksson Elementary was announced to the Board, but members did not feel this was an item necessary for their approval. Parents were to be informed of this change and provision made to allow students and their parents to meet their new principals. Leaves and resignations were approved as follows: Reinstatement for Michelle LaMirand, Spanish/French, Salem High School; Carolyn Andzewicz, Canton, Maternity Leave; Jane Paulsen, Music, Pioneer; Resignation; and Timothy Murphy, 4th Grade, Ibbister, Medical Leave.

Board member comments: A Melvindale-Northern Allen Park Board of Education resolution was discussed which would address itself to the Wayne County Special Education tax levy, and whether the Plymouth Board should support such resolution. Accreditation from the North Central Area was noted for the Centennial Educational Park for the 79th consecutive year. Early dismissal for senior students on June 6 was discussed. Field Elementary School requested prohibition of motorcycles and motor vehicles on school property, and posting of signs. Field trip permission slip wording was discussed, especially in the case of parents driving in private cars and children from other families riding with them. In addition, the question of training for staff members at each school for first aid was raised. This meeting was adjourned at 9 p.m.

Another Executive meeting of the Board was called on May 7 to discuss legal matters concerning crossing guards. Members Arlen and Gray did not attend. After this a special meeting was called, Member Arlen not attending. The annual school election resolution was approved. Mrs. Deanna Huff addressed the Board on behalf of the Citizens Election Committee, asking Board support and involvement. Delegation of the annual election procedure was made to the Superintendent of Schools, and then the meeting was adjourned to closed session. Member Gray was excused from the meeting. Expulsion hearings were conducted for students #EXP 79-5-S3, #EXP 79-5-S4 and both were denied permission to reenter the school system until parents petition the Board for permission to do so. An expulsion hearing was also held for Student EXP 79-5-S6 and for EXP 79-5-S7. After deliberations, these two students were also denied permission to reenter the school system until such time as their parents would petition the Board for permission to reenter. Member Harper abstained from voting in the case of student #EXP 79-5-S7 since there might be a conflict of interest. The meeting was adjourned at 11:30 p.m.

May 14, 1979: All members were present except Member Arlen. The meeting was called to order at 8 p.m. following Grievance hearings. Agenda and minutes were approved. Mrs. Deanna Huff again spoke to the Board regarding the millage election publicity. A meeting of MAISL was announced for 7 a.m. on May 19, and a letter was reviewed from State Dept. of Education which asked this School District to return an overpayment of \$8,118.31 for Food Service. School pairings for ESY opt-outs were reviewed. Fiegel School was set to be included in option schools this next year since it does have increased enrollment.

Administration Reports: A voters survey was presented regarding upcoming millage election opinions, and setting priorities for election issues.

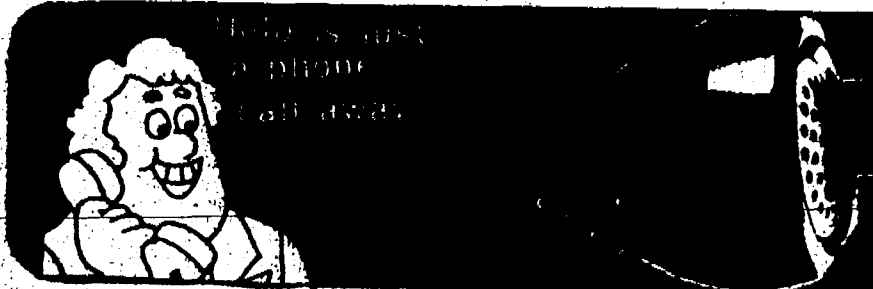
Old Business: A warranty deed was presented to members of the Salem Area Historical Society for the Salem Stone School. They requested help with yard work, and with financial aid as well for restoration of the property.

New Business: Several resignations, etc., were approved: Betty Walker, Bird School, Medical Retirement; Doris Bur-bower, Smith School, Retirement; Lucille Finckhauer, Allen School, Retirement; Margaret Kelly, Salem High School, Retirement; Carla Garbin, Canton, Resignation; Janet Cherrity, Canton, Resignation; Nancy Hahnshuber, PPS, Resignation; Nancy Werabop, Ibbister, Resignation; Cynthia Burstein, Salem, Maternity Leave; Cathie Kerr, Allen, Maternity Leave; Claudia Tull, Miller, Study Leave.

In addition, the resignation was accepted with regret from Mrs. Helen Moore, Supervisor of Accounting for the School District; and the resignation of Mrs. Carolyn Sellman, Clerk for the Board of Education, was noted. Bills in the total amount of \$2,073,321.76 were approved for payment. A bid for conversion of the main heating unit at East Middle School from fuel oil to natural gas was approved to Heat Heating Company for a low bid price of \$41,588. A resolution was also approved to make application to the Michigan Municipal Finance Commission to issue a \$9,000,000 Tax Anticipation note to run until April 1980. It was also a consensus at this time that summer tax collections should again be considered by governmental units within the District, so that such tax anticipation notes would not have to be sought.

The meeting to be held on May 28, 1979, was then cancelled by resolution, due to the Memorial Day Holiday, and administration was authorized to pay any necessary bills in the interim. The Board directed administration to communicate its support for the Melvindale-Northern Allen Park Board of Education resolution regarding distribution of Special Education funds at the County level.

Board member comments: Member Gray noted that if he had been present for that portion of the special meeting of May 7, he would have voted against the 1.5 mills request to be placed on the June 11, 1979 school election ballot. Priority for possible cuts was discussed, with this item being only a matter of information from administration at this time. An article in the Wall Street Journal was referred to Board and administration regarding teacher associations, contingency, etc. The meeting was then adjourned at 9 p.m. and the Board followed this with a discussion of direction to administration regarding disposition of grievance PCEA #78-79-7 and Transportation 79-79-5. 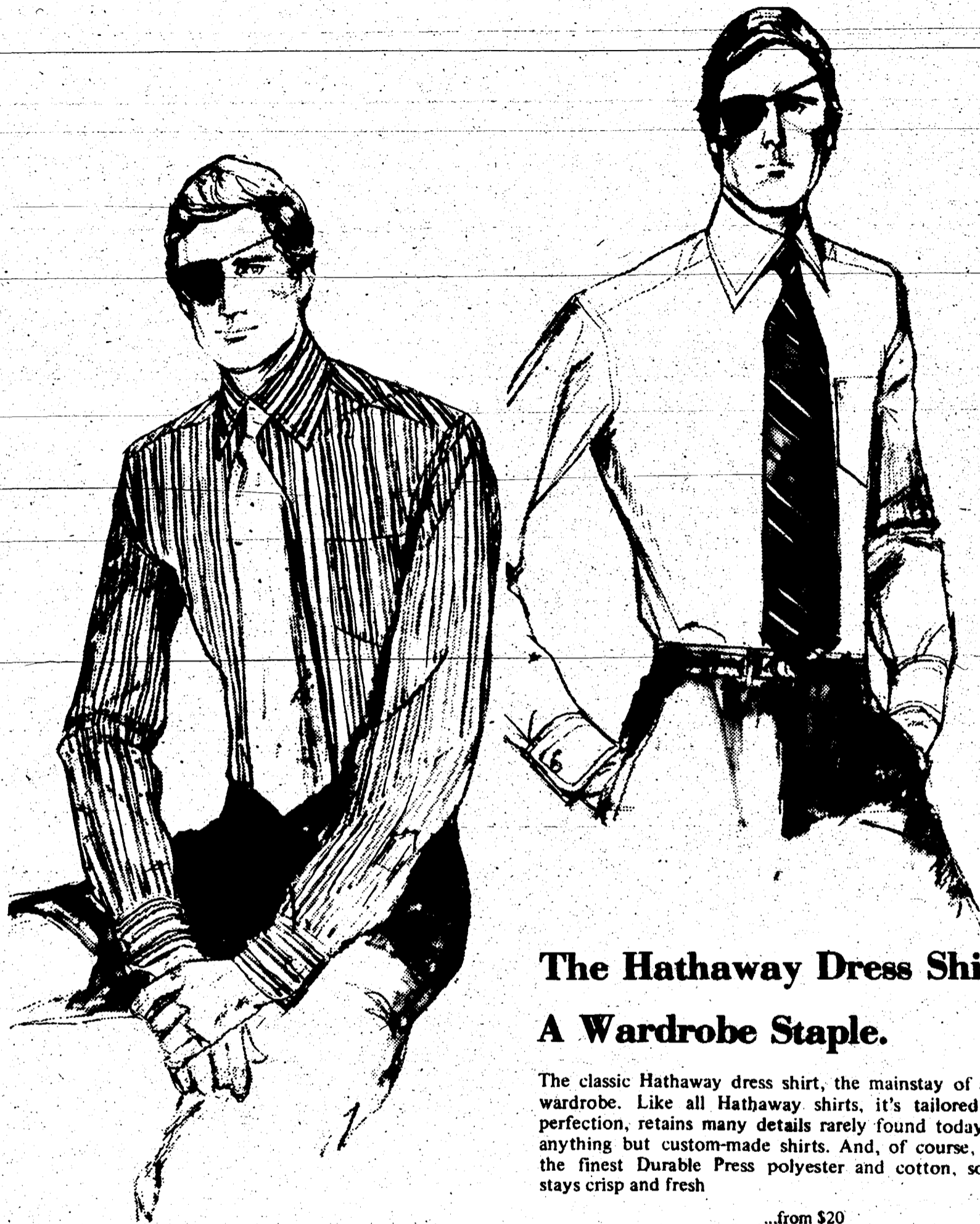
