Senior living complex planned for township

Plans are taking shape in Plymouth Township for a 253-unit senior living community off of Ann Arbor Road west of Haggerty, near the CSX Railroad tracks.

also include a 7,000-square-foot commercial building with frontage on Ann Arbor Road, on what is now the site of Plymouth Elks Lodge 1780.

The township Board of Trustees on Tuesday unanimously endorsed a PUD, or planned unit development, designation for the site.

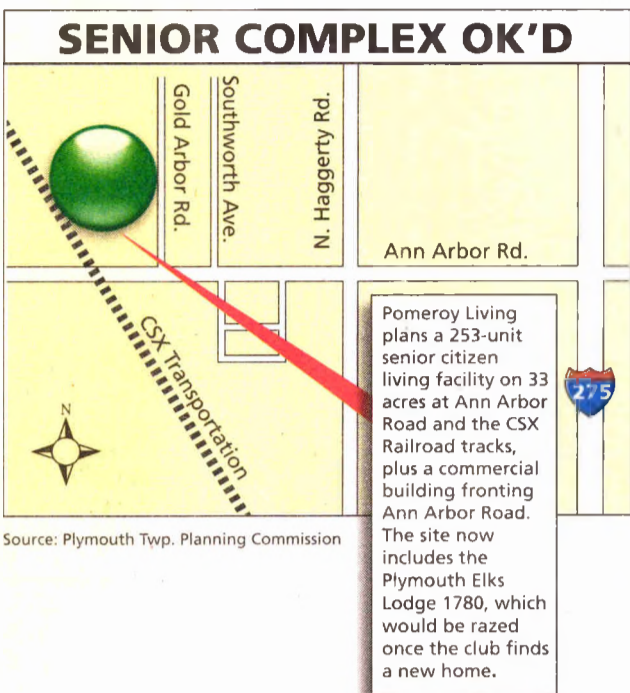
Township Supervisor Richard Reaume said the project, on land now zoned for industrial use,

would better fit in with the character of the neighborhood.

Walkable area

"In addition, the new living complex will complete the township's vision for an integrated walkable community located next to the Plymouth Town shopping center," Reaume wrote in an email.

Valet parking back in downtown Plymouth

After an absence of more than two months, cold-weather valet parking has returned to downtown Plymouth.

Valet service in front of Compari's, on Main Street near Ann Arbor Trail, began last weekend after restaurant owner Frank Yaquinto and the Plymouth Downtown Development Authority got permission to park vehicles at the PNC Bank lot down the street.

"We find it to be pretty convenient, especially in the cold weather and the snowy weather," Bruscato said.

The valet service, provided by First Class Valet of Troy, is \$5 per vehicle. It will typically be offered from 6 p.m. to midnight each Friday and Saturday until about mid-April.

Parking multiplier

Several on-street parking spots will be reserved for staging during valet hours, but Bruscato said the program translates into increased parking, as vehicles parked by the service go to a private lot and not public parking.

"That's 40 cars that aren't taking up public parking downtown," he said.

PNC Bank is not charging for the use of its lot. Bruscato said the bank had approached the DDA to find ways it could get involved in

STEM students pass on passion for science

Sena Al-Ado has a passion for science she really wants to pass on to younger kids.

That's why Al-Ado and a couple of other students from the Plymouth-Canton Educational Park STEM program were at the Plymouth District Library on Thursday, explaining how the heart, arteries and veins

work in the body to about a dozen middle school-age children.

It's part of a monthly outreach program STEM students work on to impart their knowledge and love of science and engineering to younger kids.

"I love science," said Al-Ado, a junior at Canton High School who serves as president of the STEM Stu-

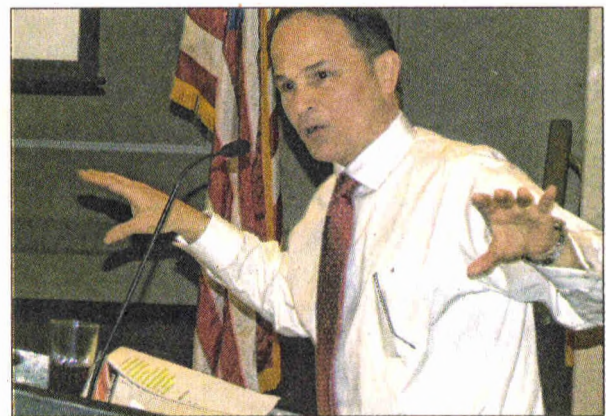
Scott LaRiche, vice president of Lou LaRiche Chevrolet in Plymouth Township, will chair next year's North American International Auto Show, exactly 30 years after his father Lou chaired the 1985 Detroit show.

"I get to follow in his footsteps and that's really special," the younger LaRiche told members of the Rotary Club of Plymouth on Friday, during a

travelogue on auto shows he's attended around the world.

LaRiche, who in 2013 was president of the Detroit Auto Dealers Association, worked his way to the NAIAS chairmanship over several years as a member of the show's executive committee and a DADA board member.

As part of his preparation,

dent Council at The Park. "If I can get another moment in the day doing something I love, that's what I'm going to do."

The STEM kids make the trip to the Plymouth District Library monthly, in learning sessions that are open to any middle school students in the Plymouth-Canton boundaries, including those in public, private and charter schools.

The classes alternate

between biomedical and engineering lessons. For instance, in the April class, students will try to build the best cushion to save an egg dropped from different heights. Last month, they built towers out of spaghetti noodles and marshmallows.

The idea, according to STEM coordinator Danielle Ramos, is to get kids interested in science at an early age.

"Kids can lose interest in science at an early age, so we're trying to keep them engaged," Ramos said. "Introducing

them to STEM lessons gives them a little glimpse of what the high school is going to offer."

That's one of the main reasons the STEM kids volunteer to do the teaching, according to Canton High School sophomore Maha Zahid, the STEM student council's vice president.

Zahid said the STEM students "do a lot of outreach."

"This is a way for us to share our knowledge and our passion for what we do," Zahid said. "We wanted to share it with these young kids so

they're ready for what they'll see in high school."

At Thursday's session, the middle schoolers got to handle actual sheep hearts to learn all about the heart. It's a hands-on way of teaching the students really respond to.

"In science ... you have a theory or an idea and you get to implement it," said Barb Dinan, the teen librarian at the Plymouth District Library. "The kids love to be hands-on."

LaRiche has been visiting auto shows around the world. He offered Rotary members Friday his impressions of four of those shows, illustrated with slides.

### World tour

At the 2013 show in Tokyo - formally called the Tokyo Motor Show - there were no displays from Detroit's Big Three automakers.

"No Ford, no Chrysler, no Chevrolet - zero," he said.

In contrast, though, LaRiche noted a hunger for American vehicles at the Shanghai auto show in China.

"Ford had a huge presence there. Chevrolet has a great presence there, as well," he said. "Everybody wants a foreign vehicle. They want our cars over there."

LaRiche said the Shanghai show was well-attended and well-patrolled by heavily armed guards. The city itself, he said, was beautiful, but smoggy. New architecture and construction contrasted with the old Shanghai, he said.

"Every place we went, there was construction going on," he said.

At the Frankfurt show in Germany, LaRiche was impressed by the show site: about three million square feet in 11 different buildings, including two large display buildings that are put up and taken down every year just for the show.

LaRiche also went to the show in Geneva, Switzerland. "It's one of my favorite in the world because of the clean lines," he said.

### Improved Cobo

LaRiche said the authority that runs Cobo

Center in Detroit, which hosts the NAIAS, has made great strides in renovating the facility.

"We had some issues over the years," he said. "We had a world-class show at a place that was literally falling apart."

Set-up for the NAIAS typically begins in late October and runs until the show opens up every January, LaRiche said.

"They never miss a beat," he said. "They always find a way to get this show open and on time."

The site is made up of a vacant 27 acres, plus the six-acre Elks site. The Elks Lodge would be razed once lodge members find a new home.

A rendering filed with the township shows a wooded perimeter and a circular main driveway at the senior complex, with the independent-living apartments in the center of that circle and most of the villas scattered outside of it. The indepen-

dent-living complex includes a commons area for meals and social and physical activities. The assisted-living building, called Beacon Square, is at the southern end of the site, as are four of the villas.

Reaume said parts of the site included ground contamination from a steel plant that used to sit there. Though the site has been cleaned to the state's satisfaction, he said, Pomeroy's plans keep living quarters away from areas where the contamination was thought to have been heaviest.

improving downtown. "PNC Bank has been a great partner," he said.

Under township ordinance, a valet service using city parking spaces pays a permit fee of \$400 per season, which runs November to April. Yaquinto, who also owns Fiamma Grille and The Sardine Room, on the same block as Compari's, paid the fee. The valet service, however, is open

to anyone visiting downtown.

This is the third year for downtown valet service in front of the restaurants. During the first two years, Brusca said, vehicles were parked at what was Saxton's Garden Center on Ann Arbor Trail, but most of that building is now occupied by Crossfit Lower Town and the fitness club's members use the lot in the evenings. Saxton's itself closed in late 2012, though a small-engine repair service remains in the back.

# Township settles final claim over damaged trees

Plymouth Township has reached a seventh and final settlement with the chemical manufacturer DuPont over a weed-control agent blamed for damaging more than 100 trees in parks and other township properties.

The latest settlement, unanimously approved Tuesday by the Board of Trustees, concerns three damaged trees at the Plymouth Community Fire Department's Station No. 3, at North Territorial and Beck. DuPont will have the trees removed and pay nearly \$29,000 for tree replacement, future tree maintenance and added compensation. DuPont is also offering a limited warranty against future damage from Imprelis.

Imprelis is a DuPont herbicide, used in the township in 2010 and 2011, that was later linked to reports of tree damage. DuPont has been working to settle Imprelis-related claims for more than two years.

Last fall, the board approved six settlements pertaining to tree damage on other properties, including the township hall site, Plymouth Township Park and Lake Pointe Soccer Park, where some 61 trees were slated for removal. The final settlement brings DuPont's total payments to the township to about \$480,000.

### PCFD radio upgrade

The township will spend just over \$180,500 to replace the Plymouth Community Fire Department's more than 20-year-old radio system.

The department's

current VHF system will be replaced by an 800-megahertz Motorola system that, Fire Chief Mark Wendel said, will allow better radio communication between firefighters and township police officers and between the PCFD and other fire departments in mutual-aid situations.

Most fire departments in the area have moved to 800 MHz systems, Wendel said. The PCFD's current radios have become unrepairable because parts aren't available, he said.

The equipment, including radios for the fire stations, fire trucks and ambulances and hand-held models for firefighters, will be supplied by Com-Source Inc., a Rochester Hills company that, the fire chief said, is planning a move to the township.

The township board unanimously approved the purchase Tuesday.

### New defibrillators

The fire department will also replace two of its heart defibrillators with newer, updated models. Trustees approved the sale unanimously Tuesday, with a price not to exceed \$71,898.60.

The defibrillators are being supplied by Physio-Control Inc., a Redmond, Wash.-based company. Chief Wendel said that buying them through Huron Valley Ambulance, a private paramedic service in the area, will save about \$3,900. The fire department last bought new defibrillators in 2008.

Defibrillators are used by paramedics on heart patients during medical runs.



**PALINDROMIC ARTHRITIS**

Physicians are aware that nature has curious ways; a good example is palindromic arthritis. In biology a palindrome refers to a phenomenon that starts and ends, but does so by reversing itself.

A form of arthritis provides an illustration. There is an arthritis, appropriately called palindromic arthritis, in which the arthritis begins in a single joint, say the wrist. The wrist pain and swelling often is extreme, but if not treated may last one to three days and then lessen. However, while the wrist joint is recovering, the elbow or shoulder joint becomes inflamed. The arthritis may next march across to the other arm going from shoulder to elbow to wrist. Or the condition may travel to the knee and then the ankle.

Resolution occurs in reverse. If the left wrist was just inflamed, but stops completely, then the person with palindromic arthritis knows that the left elbow will be the next site where the pain will end. The episode will keep rewinding back to the right wrist where the flare originally began and there it will completely end.

Physicians have no answer as to why palindromic arthritis takes on this pattern. Doctors can treat the most painful single joint with a steroid injection, but this procedure does not stop the condition from traveling to the next joint. In the effort to prevent attacks of palindromic arthritis, physicians have turned to treating the condition as if it were a variant of rheumatoid arthritis. But there are many drugs used to treat rheumatoid arthritis and a nearly infinite number of ways a physician can combine anti-rheumatic therapies. To date, no single anti-rheumatic drug or combination has proved consistently successful.

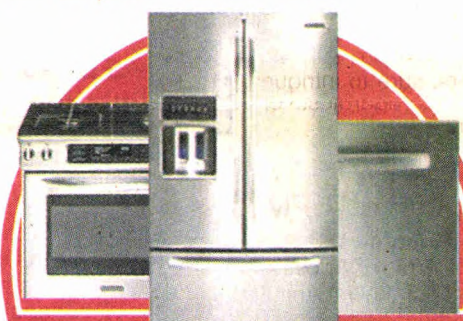

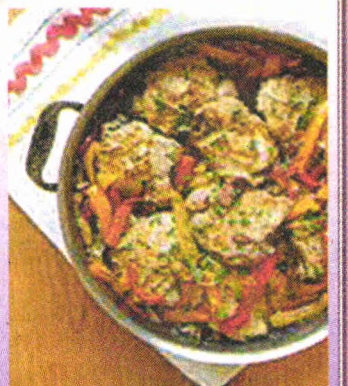

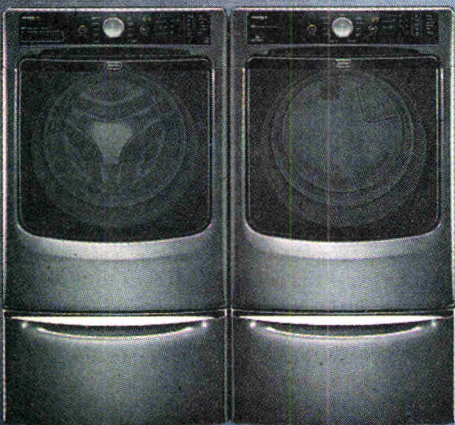

## Lightning strikes another season

P-CEP robotics team unveils 2014 robot

Lightning 862, the FIRST robotics team representing the Plymouth-Canton Educational Park, opened the build season of the 2014 competition last month in preparation for defending its third-place finish at the 2013 world championships in St. Louis.

On Thursday night, the team unveiled the robot it will use to try and match that performance.

Neo, the robot whose name comes from a character in *The Matrix* movies, features a new drive train its creators say will be easier to maneuver over a course that has fewer obstacles than in previous years.

Neo isn't quite complete, but the team felt it was time to unveil him at the annual robotics kickoff ceremony at Salem High School.

"It was tough in terms of manpower at first, because everyone's schedules weren't matching," senior driver Matt Dunklee said of building Neo. "We built a brand-new drive train. We wanted to try something different."

Changes to the competition will also make it more difficult to repeat, according to Jay Obsniuk, the longtime adviser to the robotics team. This year's competition will feature more points for working together among the three-team clusters at the competitions, as opposed to teams being more "all for one."

Complicating the issue, according to Obsniuk, because the field has grown to some 200 teams across the state, nearly half of them first-year programs thanks to a grant obtained by the state.

"You're actually going to get more points if your robot passes to another robot than if it does something on its own," Obsniuk said. "You need to be able to do as much as possible

this year, because you can't count on the other robots being able to do it. You could be out there with two rookie teams."

That's going to be the biggest challenge, especially since they won't know who those teammates are going to be until the competition.

"The biggest challenge is being able to cooperate with your teammates," said Plymouth High School senior Julian Gabriel, one of Neo's drivers and the president of the robotics club. "It's going to have to be done quick, on the fly and in complete cooperation with your teammates."

As always in Plymouth-Canton – though not with other programs, according to Obsniuk – the students did all the building, including construction, wiring and programming.

The team does have about a dozen adult mentors, but the mentors are exactly that. They don't do the work, in accordance with the team's credo, "Student led, mentor guided."

"The adults could sit down and put the robot together in three or four days," Obsniuk said. "But that wouldn't do the kids any good."

And doing the kids some good is what the robotics season is all about. That's why officials at Bosch Corp. are so eager to be involved. Bosch, with offices in Farmington and Plymouth, sponsors Lightning 862, along with 10 other teams – and some 400 students – across the country.

Bosch, which adds 14 mentors to the team, sees its sponsorship of such programs as "an investment in a great talent pool." Charlie Ackerman, Bosch's senior vice president for human relations in North America, said Bosch recognizes "there's a labor shortage," particularly in science, math, engineering and technology fields.

"We want to help in any way we can to grow the talent,"

Ackerman said. "Even better, we're beginning to get these students back into our intern programs."

The team starts its competition season with a match Feb. 28 through March 1 in Southfield. Then, March 13, the team will travel to Escanaba to serve almost as a mentor team to a competition filled with first-year programs.

The team closes out its season April 5 at Bedford, then heads to the state meet at Eastern Michigan University a week later.

"There are about 200 teams now and only 64 get to go," Obsniuk said. "It's going to be a harder road than it was before."

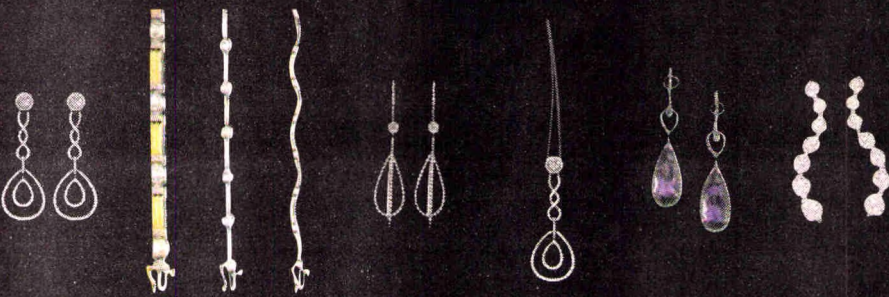


Drive team members Matt Malinak (from left), Matt Dunklee and Julian Gabriel explain the game to an attentive audience.

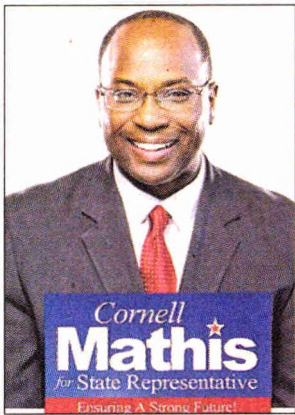

# Commissioners have mixed views of county's deficit plan

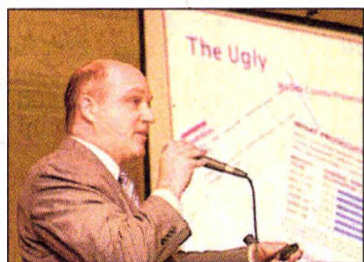
Wayne County commissioners are giving favorable reviews to a revamped deficit elimination plan that focuses on elimination of the county's accumulated deficit and elimination of the annual structural deficit.

The plan was developed by the county's new chief financial officer, former Northville Township Supervisor Mark Abbo.

"Fresh eyes and a lot of hard work from my executive team have resulted in a financial plan that we believe will resolve many of the long-term issues the county has been facing since the real estate meltdown in 2008," Wayne County Executive Robert Ficano said about the plan he presented last Wednesday to the Wayne County Commission.

"I think it's a great start to a conversation that hasn't taken place on a broader basis," said county Commissioner Richard LeBlanc, a Democrat whose district includes Garden City and Westland. "We were asked for an up or down vote all inclusive by April. We won't vote on all of it by April."

"I think (the plan) is bold and aggressive. I've been saying for the last year in order to fix the Wayne County budget, we're going to have to address collective bargaining, consent agreements, etc.," said Com-

missioner Shannon Price, a Republican who represents the Plymouth-Canton area. "The plan Mark Abbo put forward addresses not only the debt, but the structural deficit."

### 'All kinds of ideas'

Commissioner Laura Cox, a Republican who represents Northville, Northville Township and most of Livonia, said the plan is different than the ones that have been proposed in the past and she said she appreciates the thought put into it, but still is unsure about the wastewater treatment plant's inclusion.

"This plan is so different than other plans that we're used to presenting because it's got all kinds of ideas," she said. "It's got some good structural ideas."

The county is operating with property tax revenue that is \$100 million less than in 2008. The cumulative decline in property tax revenue since 2008 is approximately \$353 million. Property taxes are the

primary source of revenue for the county's general fund and support much of the operating expenses for state- and charter-mandated services.

To eliminate the accumulated deficit, pegged at \$175 million as of Sept. 30, 2013, Abbo recommends two steps: including the Delinquent Tax Revolving Fund Unrestricted Fund Balance in the county's general fund balance and reorganizing and recapitalizing county-owned wastewater treatment facilities.

Elimination of the annual structural deficit is a multifaceted task encompassing many areas of county operations. They include savings generated from:

- » Revisions to the pension and health care plans, which will result in annual operational savings to the general fund, as well as virtually all county governmental and enterprise funds. There will also be estimated savings of up to \$38 million to the accrued pension liability and \$418 million in savings to the accrued other post-employment benefit liabilities.

- » Reductions in county-wide levels of compensation.

- » Changes to employee work rules.

- » Re-prioritizing and reductions to service levels now provided through offices of both the prosecuting attorney and sheriff.

- » Reducing the number of circuit court judges, as well as benefits provided to judges.

- » Better utilization and leasing of county-owned facilities.

Noting that the changes proposed for the Wayne County Sheriff's Department, the Wayne County Prosecutor's Office and the courts – none of which are controlled by the county commission – LeBlanc said he wants "to be part of the fix."

"If the majority can be part of it – not unanimous – I'll be pleased," he said. "Whether it's the executive's plan or a commission plan that hasn't been identified yet or a hybrid, something has got to happen."

### Challenging items

A number of items in the proposal require action by other bodies and, most challenging, involve employee collective bargaining agreements, LeBlanc said. If Wayne County isn't able to get some relief through the labor contracts, he said, there will have to be services the county no longer provides, as well as fewer employees.

"Wayne County has lost significant management rights in bargaining in recent years," LeBlanc said. "I can't tell you how many times reasonable efforts to contain costs are prohibited by collectively bargaining agreements."

Price, however, said the plan should address the appointees more.

"Ficano and the sheriff still have too many appointees and this doesn't address that; that's

a big step," Price said. "I am concerned on the rape kit portion for the (county) prosecutor. We have to make sure we finish our commitment on the rape kits, make sure every lead is followed and every criminal is convicted. I'm a little concerned the plan might eliminate some of the funding for that."

"I've been pretty tough on a lot of things and I'm going to continue to scrutinize everything. But the truth is (Abbo) put out a plan that eliminates the deficit and starts to fix the structural deficit," he added. "You can't continue to have a two-to-one match on pensions. You can't continue to pay for people to have their birthdays off. Not when you're facing an emergency manager."

Cox is questioning the inclusion of the wastewater treatment plant in the plan. With several variables surrounding the plant, she said the figure provided by Ficano might not be the final number once a potential sale is finalized.

"I'm not sure we have a buyer," she said. "I don't know if it easily could be done. That bulk of this whole plan is based on the sale of a piece of property per se ... and that part, I don't know if that's an appropriate item for a deficit elimination plan. That's where my issue is and my concern."

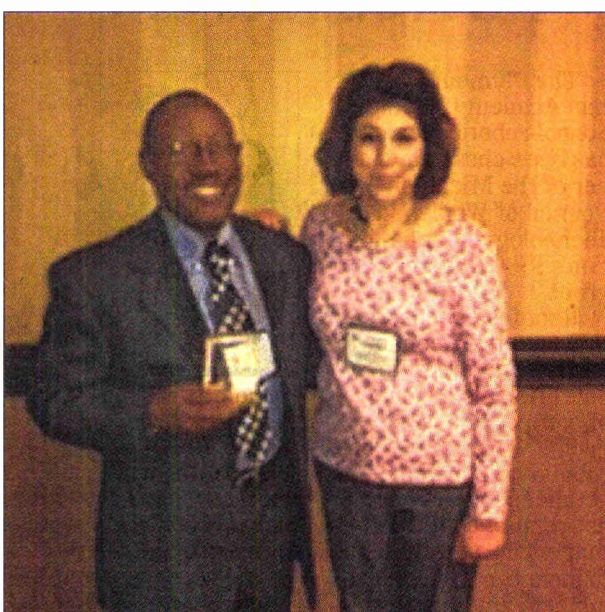

## PCA robotics team gets grant

The Plymouth Christian Academy Middle School robotics team has been chosen a winner of the Michigan Council of Women in Technology Foundation's \$500 Robofest grant.

Robofest, sponsored by Lawrence Technological University in Southfield, is a variety of competitions and events with autonomous robots – programmed to act independently and not remote-controlled – that encourage students to have fun while learning principles of physical science, computer science, technology, engineering, math, computer science and information and communication technologies.

Students design, construct and program the robots. Since 2000, more than 14,000 students have competed in Robofest.

The PCA team, an all-girls team that has been piling up the accomplishments, will be using a fully auto-

nomous robot it will program to accomplish a robotics mission.

The scenario goes like this: A nuclear power plant is in trouble and the mission is to avoid a nuclear meltdown. An autonomous nuclear responder robot has detected the problem and will instantly deliver up to three water balls (tennis balls) and a special ball (hard-boiled egg) into the plant (box) without human help in two min-

utes.

The robot can carry only one ball at a time. The "learning objectives" of this challenge, according to PCA officials, are motion, navigation, manipulation, object detection, localization, logic, ratio, proportion, math operations, measuring and geometry.

The Robofest World Championship will take place May 16-17 at Lawrence Technological University.

**Q: Dear Rick: I own my own business and have liability insurance on the business. Outside of my business, I have a decent portfolio. I have homeowner's and automobile insurance and I have been considering extra liability insurance. What are your thoughts regarding umbrella liability policies?**

**A:** An umbrella liability policy covers you for additional liability above and beyond your homeowner's and automobile insurance.

The umbrella coverage would kick in after your policy limits on homeowner's or auto insurance limits were exhausted. Like all types of umbrella liability insurance, it is not for everyone. However, in your situation, I would consider a policy.

We live in a litigious society and if something did happen, the umbrella liability policy can protect you. Even though you have liability insurance for the business, it would not necessarily

protect you individually, nor would it protect your ownership of the company. Your business is an asset and someone can go after it in a liability situation. The umbrella policy would protect your assets and be used to cover legal fees.

Umbrella liability policies are relatively inexpensive. Typically, you purchase it in increments of \$1 million and it ends up costing a few hundred dollars per year. As a business owner, that additional liability protection can be valuable in cases of accidents. In addition, for

individuals who have substantial portfolios or other assets, an umbrella policy can be used to protect those items.

Typically, you purchase the umbrella liability policy from your homeowner's or automobile insurer. It is not unusual for a company to give you a discount on the umbrella policy.

I recommend shopping your homeowner's, automobile and umbrella policy together. You may find that by having all the insurance at the same company, there may be substantial cost savings. Good luck.

# Statewide auto theft rates decline for sixth straight year

For a sixth consecutive year, thefts of vehicles are down in Michigan, according to the 2013 Michigan Automobile Theft Prevention Authority Annual Report. Despite the decrease, H.E.A.T. (Help Eliminate Auto Thefts), Michigan's statewide auto theft prevention program, is warning the community that auto theft-related crimes continue to rise.

"It's good to see the number decline," said Terri Miller, executive director of H.E.A.T. "But thieves aren't going away, they're just changing gears. As whole-vehicle thefts decline, we've seen a sharp increase in auto theft-related crimes, including carjackings, online/

Craigslist fraud, component theft and insurance fraud."

H.E.A.T. coordinates citizen action with law enforcement agencies through a confidential toll-free tip line for reporting information on stolen vehicles, chop shops and suspected auto theft activities, including insurance fraud, identity theft and carjackings.

Since H.E.A.T. was founded in 1985, the organization has recorded more than 10,000 tips. Michigan residents have assisted in the arrests of nearly 3,700 suspects of auto theft-related crimes and have helped H.E.A.T. recover more than 4,600 vehicles, amounting to \$57.4 million in stolen property, throughout the past 28 years.

"Despite the continued decline in the number of vehicle thefts in Michigan, we must continue to increase awareness of auto theft-related crime in our communities," Miller said.

### Report highlights

Among the highlights of the 2013 ATPA Annual Report, which is the data from 2012:

» Since 1986, Michigan auto thefts have decreased from 72,021 to 24,973 – a 65.3-percent decline – despite growth in both population and number of registered vehicles.

» Michigan motorists are saving \$52 annually per insured vehicle as a result of lower theft rates.

» According to the FBI, Michigan ranked seventh in number of motor vehicle thefts with 24,973 in 2012.

» Though the Detroit Police Department saw the most vehicle thefts compared to other law enforcement agencies in Michigan, with 11,504 auto thefts, the number of thefts reported to DPD has decreased by 50 percent since 2006.

» In 2012, Wayne County topped the list of Michigan counties with the highest reported motor vehicle thefts, with 15,352 (67 percent of total state thefts), while Macomb and Oakland counties accounted for 1,950 (9 percent) and 1,850 auto thefts (8 percent), respectively.

» The 2000 Dodge Caravan once again topped Michigan's list of most stolen vehicles in 2012 and thieves' top color preferences for vehicles to steal remained black, followed by white and red.

» The months with the highest auto theft figures were August, October and September.

### Hope trend continues

"We hope the drop in auto theft numbers con-

tinues year after year," Miller said. "Fortunately, the partnership between citizens, the insurance industry, law enforcement, prosecutors and H.E.A.T. can help to put an end to all auto theft-related crime. Through our 24/7 tip line (1-800-242-HEAT) and website (www.1800242HEAT.com), tipsters can do their part and anonymously report auto theft-related crime. Some tipsters may be eligible for cash rewards up to \$10,000 for their information."

H.E.A.T. works with Michigan law enforcement agencies to follow up on tips. Tipsters are awarded up to \$1,000, if the tip leads to the arrest of or issuance of a warrant for a suspected car thief or a person suspected of auto theft-related insurance fraud. H.E.A.T. offers rewards up to \$2,000 for information leading to the issuance of a warrant for a carjacking suspect. Rewards of up to \$10,000 are issued, if a tip results in the arrest and binding over for trial of a suspected theft ring or chop shop operators.

The H.E.A.T. tip line is monitored by the Michigan State Police and funded by Michigan's auto insurance companies. Follow H.E.A.T. on Facebook and on Twitter @1800242HEAT.

## Police warn against IRS phone scam that bilked area resident of thousands

Livonia police are warning residents to pay close attention to phone calls supposedly from the Internal Revenue Service stating they owe taxes and must pay them immediately.

The warning comes after a 69-year-old Livonia resident came into the police station Thursday night to report she had been scammed out of several thousands of dollars after receiving a phone call from someone claiming to be with the IRS. The man left a message on her phone Wednesday, saying she owed \$8,000 to the IRS in taxes and she needed to pay it immediately. If she didn't, he threatened her with

jail time and shutting down her business.

She initially ignored the call, but then the man called back Thursday. She called the number back on her cellphone and was told again she owed money. She believed the caller and asked what she needed to do to settle the debt.

The suspect, calling from a number with an area code in California, told her to go to the bank and withdraw the money and purchases thousands of dollars in gift cards. She purchased \$4,000 worth of Visa gift cards at the Kroger at 33523 Eight Mile and was told by the suspect to scratch off the PIN and read the numbers to him. She repeated this process, purchasing \$4,000 worth of gift cards at a

pair of pharmacies, including the Rite Aid at 47300 Pontiac Trail in Wixom and CVS at 31250 Beck in Novi.

After the suspect received the information from the gift cards, he told her she would receive a call later with a confirmation number. He did call back Thursday afternoon to the woman's home, where her daughter answered the phone. The suspect immediately hung up after her daughter asked who he was. The victim also contacted her daughter in California, where she lives in the same area code the phone calls kept coming from. Police in California were notified of the incident.

IRS officials warn taxpayers of similar scams happening and

encourage people not to fall victim to scams involving prepaid debit cards and immediate payment.

"This scam has hit taxpayers in nearly every state in the country. We want to educate taxpayers so they can help protect themselves. Rest assured, we do not and will not ask for credit card numbers over the phone, nor request a prepaid debit card or wire transfer," IRS Acting Commissioner Danny Werfel wrote in a release.

"If someone unexpectedly calls claiming to be from the IRS and threatens police arrest, deportation or license revocation if you don't pay immediately, that is a sign that it really isn't the IRS calling."

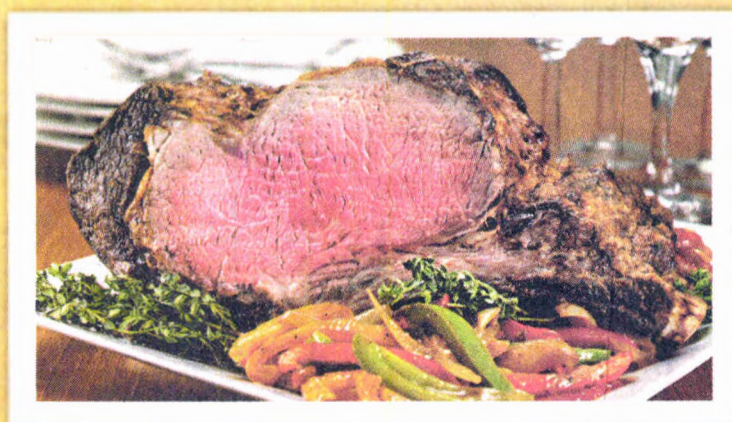

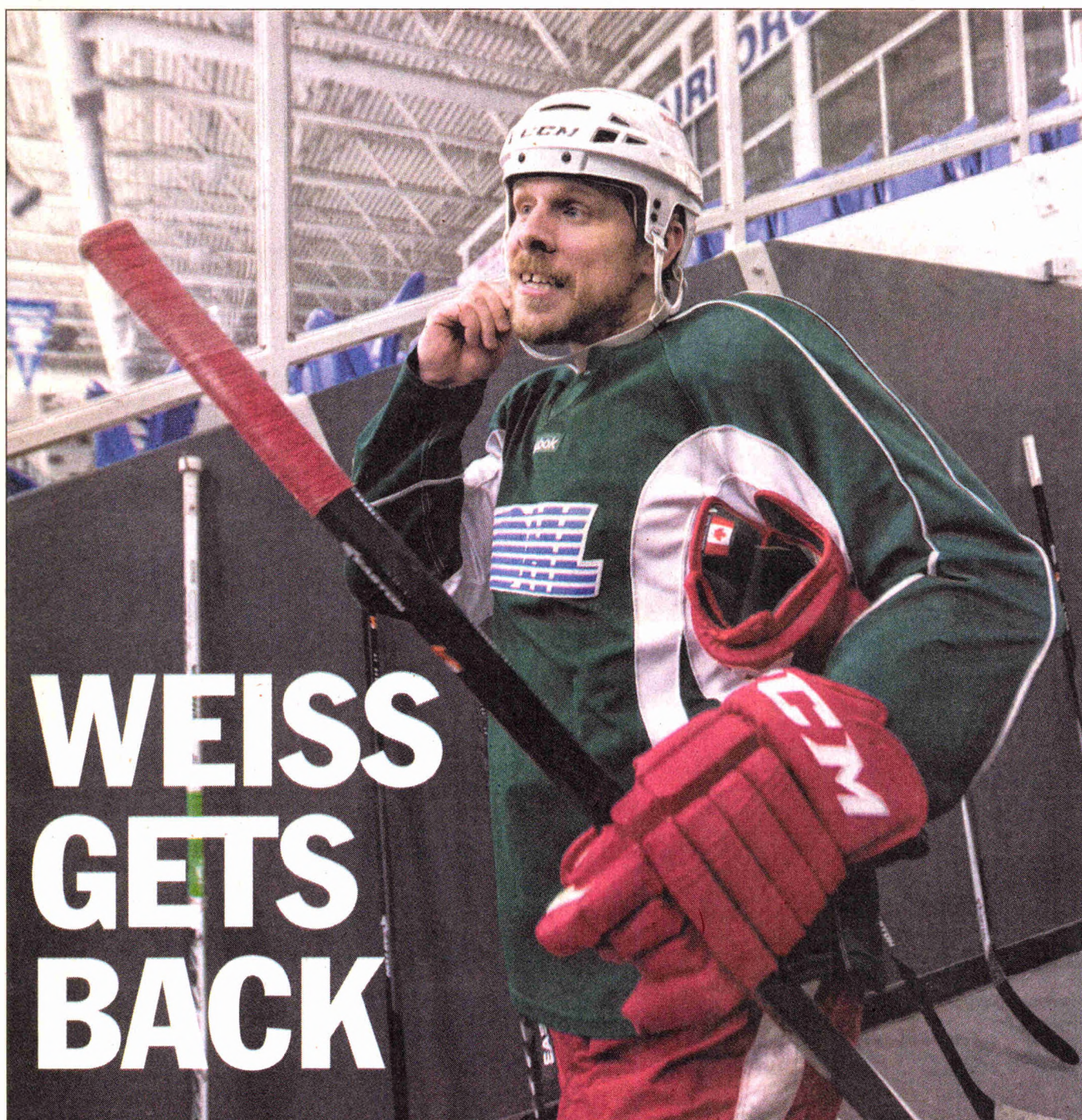

Going home week suits Stephen Weiss just fine, but being a major contributor to the Detroit Red Wings' playoff push would be even better.

Weiss — a standout player for the Plymouth Whalers from 1998-2002 and a 12-year National Hockey League veteran — last week returned to the place where he cut his teeth as a hockey player, including 2001-02 for longtime Whalers head coach Mike Vellucci.

"I didn't really want to be on my own for these two weeks, that's not a lot of fun. So to be in a team atmosphere and especially with a team that I played with before and haven't been back to this locker room for a while is pretty special."

### Like old times

He kibitzed with folks he knew during his junior days, including the

"I was going to Cancun, but not anymore," Dwyer said. "I got to cancel the flights. ... I would way rather go to Battle Creek."

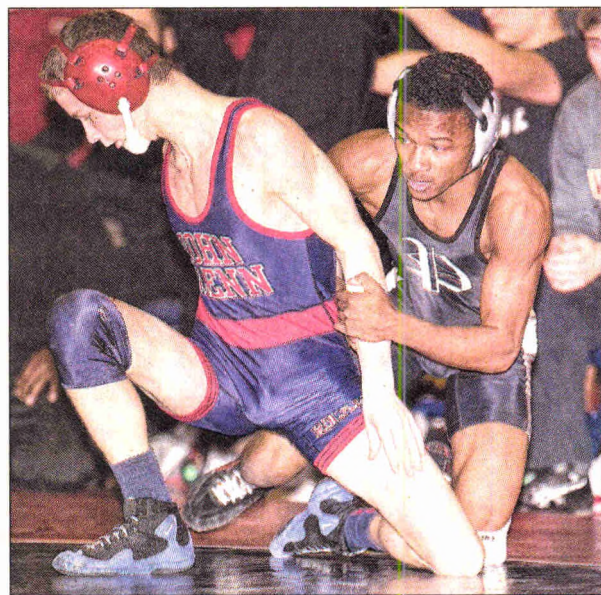
Dwyer was one of the most exuberant Wildcats, perhaps because he knew his escape act at 130 in the opening bout might have saved the day.

"It's brought back a lot of nice memories," said the 30-year-old forward from Toronto. "Veluch is still here, Veluch was the coach my last year. And (athletic trainer/equipment manager) Dennis MacDonald was here my whole time here, too. And Krupper as well.

"To see some familiar faces is always fun and I get to reminisce. Talking about the old days has been fun."

Although his billet (host) family from his years with the Whalers wasn't at the rink, Weiss said he has always maintained good communications with Plymouth's Tom and Rosie Alberti.

"Oh yeah, we've remained very close," Weiss said about the Albertis. "I'm godfather to their sons' kids now. We've remained very close. They're at a bunch of Red Wings games and we try and get together as much as we can, given both of our schedules.

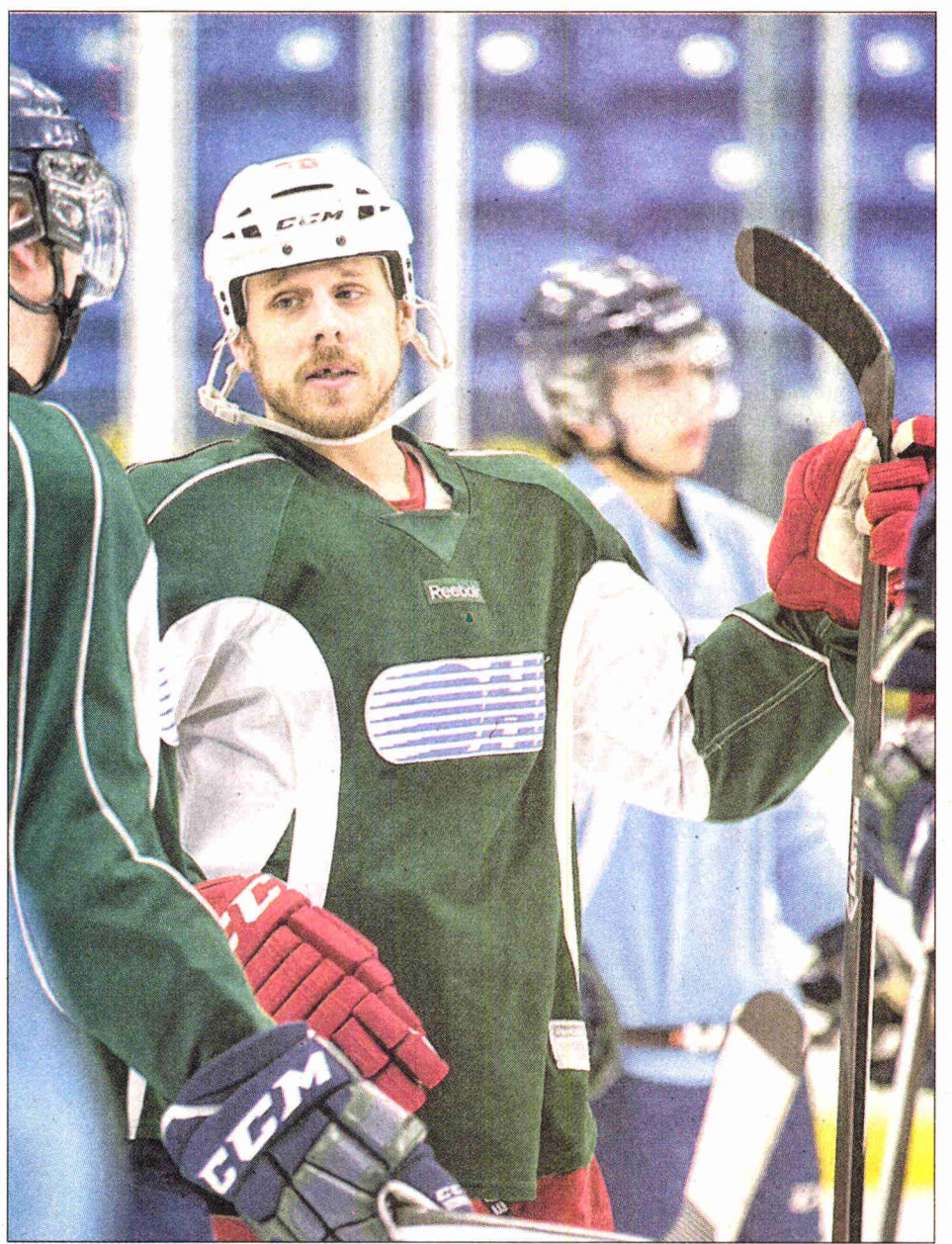
"But certainly, they were a huge part of my time here. Getting to where I got wouldn't have been possible without them taking care of me and my roommate (Cole Jarrett) the way they did."

Weiss — who signed as a free agent with Detroit after 11 seasons with the Florida Panthers, the team that drafted him fourth overall in 2001 — then smiled when he recalled telling the Albertis he was going to practice with the Whalers.

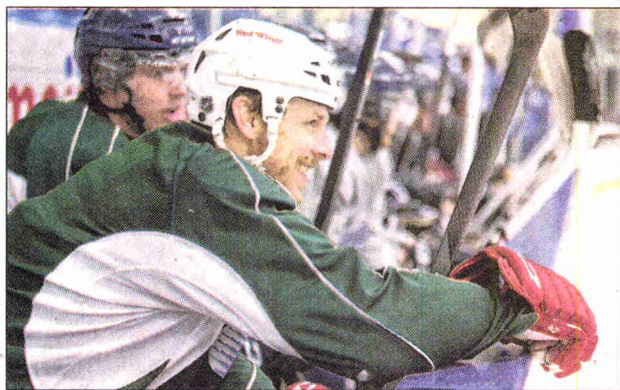
"They were pretty excited when they heard I was coming back here," he said. "We were laughing about the old days. So real special memories being back, for sure."

One of the many framed, color photographs was taken this year of Weiss wearing the Red Wings uniform.

"It's pretty cool," forward Zach Lorentz said. "You see his picture on the 'Wall of Fame' for the Whalers here. He's definitely a veteran player in the show and it's pretty cool for him to be here."

Another forward with big-league aspirations, Carter Sandlak (recently signed by the Carolina organization), said it is an incentive to see the photos. He wants his own photo up there someday.

"Seeing all those great players up there is pretty special," Sandlak said. "It's a good organization and a lot of players came from here that are playing in the NHL now."

### Just ask

Weiss said he would be happy to talk to any Whalers player who wants to get some insight into what it takes to get from Point A (the OHL) to Point B (the bigs).

"If anyone wants to chat or has any questions what pro hockey's like, I'm here for whatever they need," he said.

Today's Whalers plan

on doing just that, as well as seeing how a veteran of 680 NHL games goes about his business.

"He played in this league (OHL) and he knows what it takes to get to the next level," Sandlak said. "Just going to ask some questions and watch and see what he does."

Forward and Chicago Blackhawks prospect Ryan Hartman said it was "cool" to add Weiss to a list of NHL stars he has skated with.

"Yeah, I skated with guys like Sharp, Kane, Toews, all those guys," Hartman said. "I played two preseason games this year. It's always an honor to be on the same ice as the guys you watch playing on TV."

"And seeing guys like Steve Weiss, coming back to where he used to play and seeing that he's come through this program, it really means a lot for the Whalers."

### Then and now

Vellucci had a pretty good idea back then that Weiss indeed would adapt to being an NHL player.

"He was already taken fourth overall by Florida and he was a real good player," Vellucci said. "I think he was our leading

scorer that year, played in all the key situations and I definitely relied on him a lot."

Some 12 years later, Weiss isn't the only NHL player and Plymouth alum to have practiced with the Whalers.

"(David) Legwand skated quite a bit last year," Vellucci said. "(Chad) LaRose and (Canton native James) Wisniewski skated with us. We've had several, mostly in the lockout years."

But they all have the same attributes that he would like current players to pick up on.

"Like, how hard a guy competes in practice," Vellucci said, listing some of those characteristics. "What he does off the ice, how he maintains his body, makes sure he eats right. How he works out, not because the coach tells him, but because he wants to — because he wants to be better."

"Those are the things when you're a pro you have to take care of yourself, because if you're not, then somebody else is just going to take your spot."

And now, Weiss is almost in the same frame of mind, even though he is a NHL veteran. He is scrapping and working hard to get back to Joe Louis Arena and play on a top line, not sit in the press box while younger Wings perform.

Vellucci certainly wouldn't bet against him.

"Obviously he hasn't been on the ice in a while," he said. "But it's like old times watching him skate out there. He's got great hands, great vision."

And that trend continued Thursday night, as the Chiefs varsity gymnastics team defeated Northville 145.95-124.4 to improve to 12-0 in dual meets.

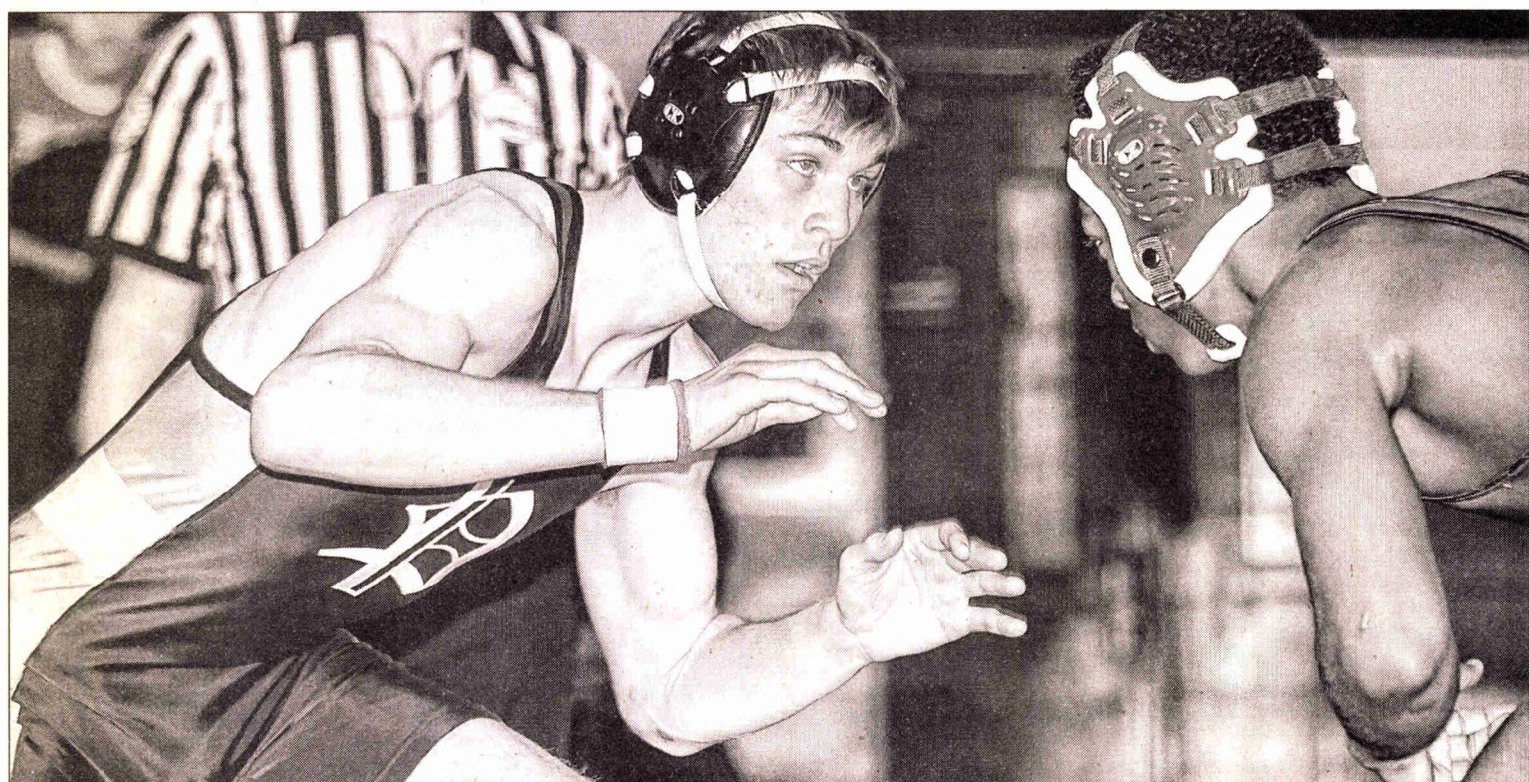
Head coach John Cunningham said that "resting Hailey Hodgson and Erica Lucas made the score much more impressive" and that overall team depth continues to shine.

# Plymouth rally downs Rockets in Division 1 regional semifinal

The pendulum swung Westland John Glenn's way as the Rockets made a bid to defeat Plymouth in Wednesday's Division 1 team wrestling regional semifinal.

But the Wildcats grabbed it back just in time to post a grueling 39-32 victory and advance to the face Bedford in the regional championship match. Plymouth hung on 32-29 in the final.

After John Glenn individual district champions Jordan Brandon and John Siemacz took 11 out of a possible 12 points at 285 and 103, the host Rockets enjoyed a 32-29 lead, rallying from a 29-15 deficit.

Plymouth, however, stormed back. At 112, Brandon Harris scored a 17-7 major decision over Cyle Sneed to put the Wildcats in front, 33-32.

And with the match on the line, Plymouth senior 119-pounder Mo Youssef took care of business by pinning Joe Bates in 1:52 to finish off the Rockets.

## Not enough

"We knew we had to be up by more points going into the

last two bouts," John Glenn head coach Bill Polk said. "I knew they probably had it on paper going into 112 and 119. That's where two of their best guys are.

"So we bumped up early and we knew that could either come back to hurt us or work out to our benefit and it hurt us. But either way, we don't bump up and Youssef has beaten (Chase) Spanos a couple times already this year, so it really wouldn't have mattered. We had to gamble a little bit and we did and it almost paid off."

After Harris came through in the second-to-last bout, Youssef knew it was in his hands whether Plymouth would win the school's first wrestling regional trophy.

"It felt real good, knowing I did it for my team," Youssef said.

"We were down and they were counting on me to win. So I just had to get the pin."

Plymouth head coach Quinn Guernsey, meanwhile, said having two district champions in Harris and Youssef waiting to go in the final two bouts gave the team reason to believe it could hold off the Rock-

ets.

"We were nervous, but we were still a little confident," said Guernsey, whose team improved to 35-4 with the win over John Glenn.

"Brandon and Mo win a lot of matches for us and they're the type of kids we expect to win when they go out to wrestle."

The Wildcats got an early jump, with 140-pounder Jon Conn pinning Charles Anderson in 1:16 and Sofus Nielson defeating Tunde Alawode 11-3 in the 145-pound match to go up 13-9.

Brad Spenn then gave the Rockets (20-10) some life, rallying in the third period to pin Sam Campbell in 4:45 at 152. That put John Glenn up by two.

The see-saw battle continued in the 160-pound match. Plymouth's Joey Shaver earned a 14-1 major decision over Derrick Lester to make it a 17-15 Wildcats lead.

Plymouth's sideline thought Shaver actually pinned Lester in the final second of the opening period. Officials ruled time had expired.

"But the last three weeks, I couldn't be happier with the efforts from some of my young ones and guys fighting and staying off their backs."

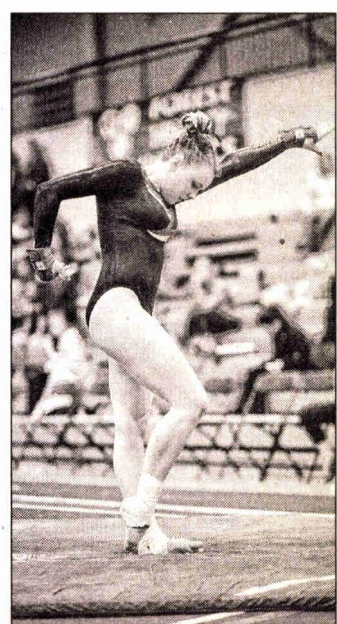
Pins by Plymouth's Tarek Tamimi and Hussein Youssef (at 171 and 189) seemingly put the Wildcats in front to stay, 29-15.

Plymouth led for a while, gave it up and had to charge back in the final bouts in both instances.

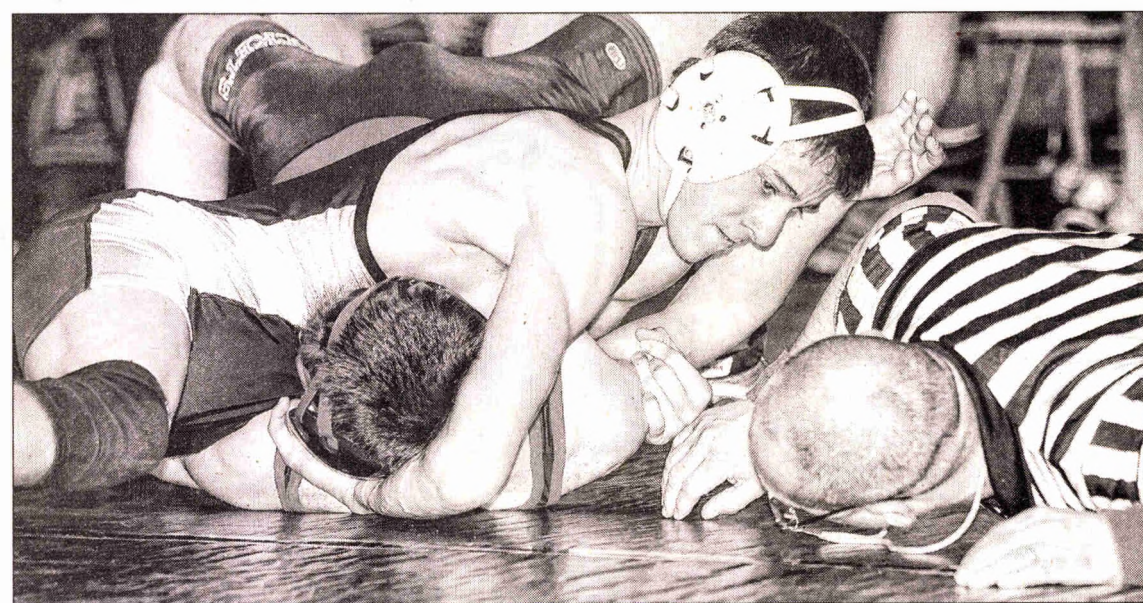
And how Dwyer gutted out his win wasn't the team's lone example of heart on display at John Glenn.

# Rocks get up to speed in time

Tournament time always seems to pump up the Salem varsity boys basketball team.

Well, sometimes it takes a while.

Thursday's opener of the KLAA tournament didn't start off very well for the home team, as Plymouth — sparked by 10 points in the second quarter by sophomore forward Brent Davis — dominated the boards and trailed just 26-22.

Salem coaches pointed out some simple facts during the intermission and a dramatic turnover in the second half led the Rocks to a 67-47 victory. The 14-2 Rocks will play a second-round game at 7 p.m. Monday at home against South Lyon (winner Thursday against Livonia Churchill).

"They (Wildcats) controlled the glass," Salem head coach Bob Brodie said. "We did not get to the free-throw line very well, we weren't scoring in transition and we weren't doing a very good job on the glass."

"The coaches brought that to my attention at halftime and said we only had two rebounds and no free throws. ... We decided we had to do that the second half, the kids kind of took that as a slap in the face and they took care of business."

On the flip side, Ply-

mouth head coach Mike Soukup was understandably downcast about how his team (7-9) gave up 41 points in the second half.

"They notched it up to championship level, we just continued the status quo," Soukup said. "I can't coach effort, that's tough when you have to do that. That being said, maybe this will be a lesson they learn. It will be another string of games that 'could have been.'"

Keeping the Rocks in the ballgame early on was senior guard Connor Cole, who tallied 13 of his team's 26 points before the break. He wound up with 18 points all told.

## Nuts and bolts

In the second half, the Rocks got back to the usual game plan of getting inside for rebounds and put-backs. Salem outrebounded Plymouth 44-20 for the night, with 42 of those boards coming after halftime.

"They got to the rim and got a lot of put-backs and opportunities," Brodie said. "When you're getting a lot of opportunities at the offensive basket, you're going to knock some down. I think that spread our game."

Strong on the glass to key Salem's second half charge were junior forward Tyler Brooks (11 rebounds and four blocks), senior center Michael Hoover (10 boards) and junior guard

Jake Lenders (eight boards).

Senior forward Alec Winfrey tallied 11 points, with senior guard Brady Cole chipping in 10 points and six assists. Brooks and Hoover also scored eight and six points, respectively, while junior forward Allante Wheeler contributed five.

After his hot streak in the second quarter, Salem put the clamps down on Davis, limiting him to 19 points total.

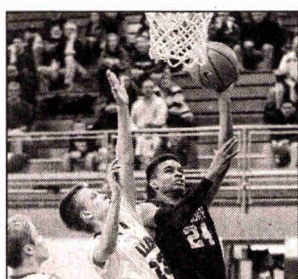
As for the rest of the Wildcats' offense, junior wing Josh Reynolds scored eight points (six on a pair of treys), but all of that scoring was in the fourth with the outcome decided. Sophomore forward Chris Walls and junior guard Randall Aikins each collected six points.

"He (Davis) played a fantastic game, I couldn't agree more," Soukup said. "But again, we didn't play hard enough on the defensive end of the floor."

"We cannot play games in the 60s and it was shown tonight. They played a game in the 60s. We can only play games in the 50s, at best."

Plymouth drops to the consolation bracket, while the Rocks are still alive, hoping to duplicate the success of 2012 (KLAA tourney champions).

"It's nice to move on," Brodie said. "You're

always vying for a championship and that's nice the way this is set up, to be in a tournament format, to go into semis for the conference championship.

"They're winners, these kids like to compete. They won the Christmas tournament, they won the division (KLAA Central) and now they want more."

Javon Taylor scored 13 points for Canton, with Greg Williams and Logan Ryan tallying eight and seven, respectively. The top rebounder for the Chiefs was Jordan Nobles, with nine.

But Salem missed a makeable shot at the other end of the sequence.

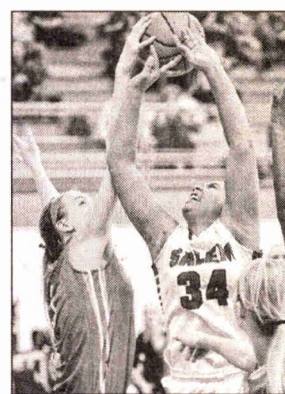

# Blessed: Redford woman marks 50 years in church music

Pat Knorp was a high school sophomore when she made her debut as a church organist at her Pontiac parish.

"The music director had a full-time job and couldn't do the daily stuff. I started on the first Friday of Lent. It was Stations of the Cross. By that summer, I was doing the 6:30 a.m. and 8 a.m. Masses every day," recalled Knorp, now a Redford Township resident. "I'm not a morning person. It's just something I knew I had to do, so I did it. Back then, the organ was in the balcony. I remember a few times I went in with curlers in my hair."

In spite of the early morning hours and the challenge of singing in Latin, Knorp knew she had a calling in sacred music. She marked her 50th year as church pianist and organist on Friday, Feb. 14.

"I just feel so blessed because I'm so fulfilled by doing this," said Knorp, who has been married to her husband, John, for 45 years. He sings in her church choir at St. Priscilla Catholic Church in Livonia and serves as a "roadie" for her handbell choir, the Valtones. The couple has four grown children and 12 grandchildren.

"I just feel that God had chosen this for me and blessed me with it. I can't imagine not doing it. It's a big part of who I am. Every holiday, I have to be at church and not with family. You give up a lot, yet you get back so much."

## Juggling music duties

Knorp has been music director, pianist, organist and adult choir and handbell choir leader for St. Priscilla's three weekend Masses for the past three years. Before that, she worked at a dizzying number of parishes, sometimes handling duties at two churches simultaneously.

"I was younger then. I didn't know any better," she said, laughing, as she considered the jobs that had her playing at early morning daily Masses, followed by occasional funerals and then music classes in the afternoon, along with choir practices at night and weekend Masses.

After graduation from St. Michael's School in Pontiac, Knorp earned an undergraduate degree in speech and drama, with a music minor, from Mercy College. After leaving school, she began playing for daily Masses at St. Valentine in Redford — a job she held for 25 years — while also teaching music at St. Scholastica in Detroit. Teaching stints followed at St. Edith in Livonia and St. Valentine.

nia and St. Valentine.

She took on the music director's position at St. Lawrence in Detroit, before moving to St. Hugh in Southgate, where she worked from 1977-87. Knorp also spent 14 years at St. Kenneth in Plymouth Township, one year at St. Mary Magdalen in Melvindale, before landing at St. Damian in Westland, and then St. Priscilla.

"When a new pastor comes in, many times he brings his own people," Knorp explained. "So, it's not just up to me to leave. I've just learned to trust God, that he has a plan for my life."

Sometimes, parishioners leave with her. She figures about two-thirds of her choir from St. Damian followed her to

St. Priscilla.

"They are a wonderful group. I feel so blessed," she said.

Highlights of her career have included writing passion plays and variety shows, the formation of the Valtones and choir tours throughout Europe, including a visit to the Vatican in 1993 when she not only met Pope John Paul II, but also held his hand.

## Adding musicians

When Knorp first started playing for Masses, the congregational responses were in Latin. Generally the organ was the only accompaniment for vocals.

Now she tends to play more piano than organ music at Mass, which is said

in English. The musical accompaniment also includes parishioners Kevin Murphy on guitar, Tim Hayword on bass, his wife, Kathy on flute, and Dave Capman on drums.

"I have other musicians that are not parishioners who come in for special occasions," she added.

She chooses songs to suit the weekly readings at Mass.

Parishioners Joyce Kelley and Mary Morrison help her organize the music for the choir.

"I am blessed. They help me immensely."

Knorp also burns CD recordings to help choir members practice new material. She's learning how to distribute the songs to choir members via the Internet and she doesn't plan to retire any time soon.

"As long as they want me there and I have a thinking mind and hands that move, I'll be there. I really feel this is what I'm called to do."

# Choir therapy gets its own awareness week

The Therapy Choirs of Michigan, based in Farmington Hills, will perform the 16th annual Capitol Concert at noon Wednesday, March 5, in the beautiful Rotunda at Michigan's Capitol Building in Lansing. The event is free and

open to the public.

This year's performance is sponsored by state Rep. Vicki Barnett, D-Farmington Hills. One year ago, Barnett worked with TCM pursuant to a legislative proclamation denoting the first week of March as Choir Therapy Awareness Week in Michigan. This work was successful and the proclamation was adopted. Since that time, TCM has been working with Barnett's office on a National Awareness Week. I'm pleased to announce that the national proclamation will be presented at the Capitol Concert. Henceforth, the first week of March will be proclaimed "TCM — Choir Therapy Awareness Week in America."

Choir therapy is the assembling of individuals who share a common challenge so that they can experience the joy of singing with others. (Good singing ability is not required.) While providing this pleasure, choir therapy also may aid an individual's adjustment in overcoming hardships. A therapy choir is composed of individuals with special needs such as people with traumatic brain injuries, developmental disabilities, mental health issues, addictions and physical challenges, such as blindness, paralysis and orphan diseases. Typically, individuals in our society who live with these kinds of problems are in the process of overcoming difficult things. Choir therapy has been shown to assist people with unique challenges.

## Benefits

Choir therapy can increase self-esteem, improve memory and related cognitive functions and enhance social

skills. In addition, choir members can gain the opportunity to construct interpersonal relationships and obtain personal enjoyment through membership in a group that is supportive, educational and congenial.

Again, good singing ability is not required! There may be some individuals who, because of stroke, speech impediment and other conditions, are unable to sing. In choir therapy, they may be able to hum, tap their cane, clap their hands, etc. In our experience over the past 15 years, we have found this use of music to be a wonderful experience for all participants and audiences.

TCM typically performs a *cappella*. However, there are times when a tambourine, a keyboard or other musical instrument is employed. The musical repertoire ranges from traditional songs and folk music to patriotic songs and contemporary pieces. TCM's work is about more than just singing. Participants and audiences, as well as volunteers, have repeatedly reported posi-

tive effects in the way they experience themselves and their world. Beaming smiles of pride at the close of events are typical.

## Volunteer voices

Volunteers from the community, be they able-bodied or with their own special needs, are an important part of TCM. Volunteers assist in many ways. Some lend their voices for volume and modeling, some assist a member with turning pages of a songbook or help singers don their choir robes. Over the years, volunteers have included the chaplain of the Royal Oak Police Department, the director of outreach from the Michigan Opera Theatre, select members of the Finnish Chorale Group and even a member of the Rockets song/dance troupe.

In addition to hearing a wide variety of musical tunes, audience members typically walk away with a new awareness of the fact that there is life after a tragedy. Awareness of choir therapy

simultaneously increases awareness of the misfortunes that many in our society experience. Members of the audience can go away with hope and take home compassion.

## Venues

TCM has been fortunate to perform at private and public functions statewide, at assisted living homes, hospitals, rehabilitation centers and rescue missions, as well as schools, from kindergarten through college. TCM has had the special privilege of singing for former President Jimmy Carter at a Habitat for Humanity luncheon. Its members have sung at a Detroit Tigers game, a Detroit Red Wings alumni fundraiser, the Cathedral of the Most Blessed Sacrament's annual Mass for the disabled, the annual Michigan Students Against Drunk Driving conference in Traverse City and even at the Fox Theatre for a sellout crowd of 5,000 patrons prior to Moscow Ballet's Great Russian Nutcracker Performance.

We all know that song and music have long been known to have healing qualities and other benefits. Lullabies calm our infants, singing ABCs helps our children memorize them, cadence calls help prepare our military with discipline, the sound of *Taps* helps us grieve when we bury our loved ones.

As the Therapy Choirs of Michigan's website states, "It's about more than just singing." As an anonymous writer from Finland once said: "If you wish to sing, you will find a song."

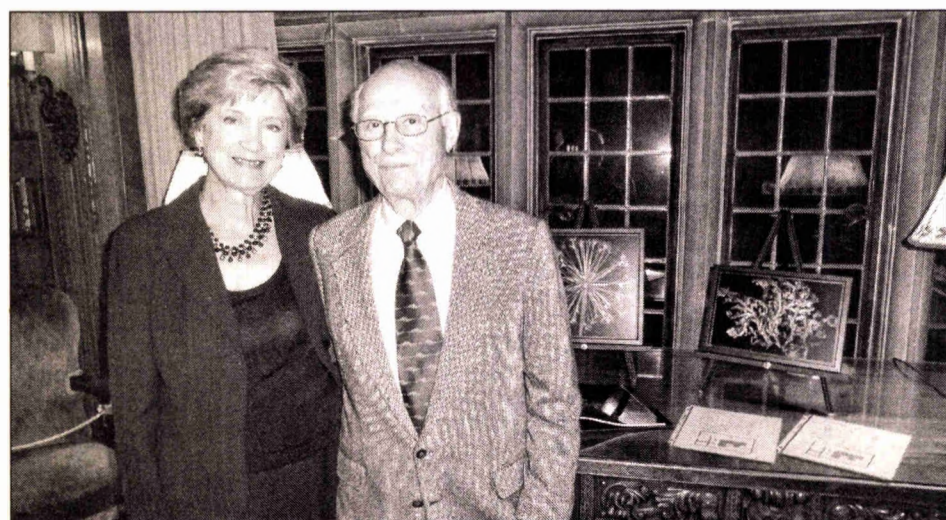

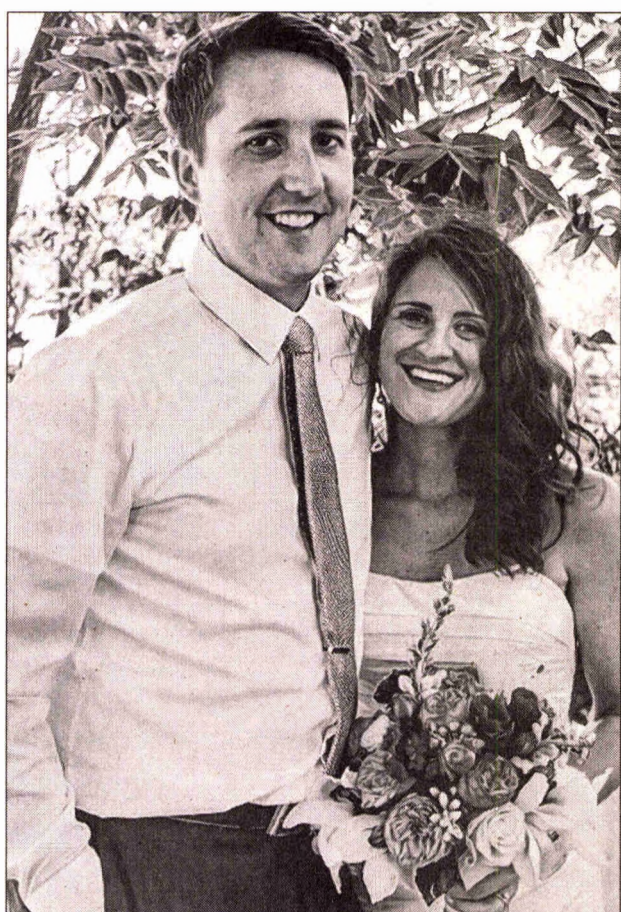

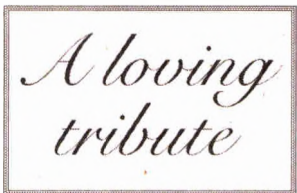

## New standards aim to make children's compound prescriptions safer

A statewide initiative led by a University of Michigan team aims to reduce pediatric medication errors and make Michigan the first state to standardize concentrations for children's liquid prescriptions.

U-M and the Michigan Pharmacists Association have announced the release of the new standards published on [mipedscompounds.org](http://mipedscompounds.org) as part of a campaign to educate prescribers and pharmacists. The move comes after a survey of 200 Michigan pharmacies revealed potential safety risks posed by the lack of standardization of compounded pediatric oral liquids for more than 110 different medications.

In Michigan, more than half of the compounded drugs had at least three different concentrations being compounded by various pharmacies. Some concentration levels were up to 30 times higher than others.

"One of the greatest dangers associated with this variation is that children may switch pharmacies but continue to take the same volume as always — without parents or even doctors realizing that the drug's concentration has changed and that a new dose volume should be prescribed," said project lead James Stevenson, Pharm.D., chief pharmacy officer of the MHS Pharmacy Services Department and an associate dean at the U-M College of

Pharmacy. "The drastic differences in concentrations patients could re-

ceive depending on which pharmacy compounded their prescriptions were deeply concerning, and these uniform standards are essential for patient safety."

Children often are prescribed oral liquid prescriptions instead of pills. Medications that are not commercially available must be compounded by a pharmacist.

"Transitions in sites of care, including movement between the home and the hospital as well as between pharmacies, are associated with patient safety risks and this may be especially true in the pediatric population because of the number of liquid medicines that must be compounded," said Chris Dickinson, M.D., a co-investigator on the project.

"It has been gratifying to see this statewide collaborative effort and we encourage all prescribers and pharmacists to adopt the standard concentrations in the interest of improving medication safety in our pediatric population."

The initiative has prompted standard concentrations for nearly 120 drugs that are available on the new [mipedscompounds.org](http://mipedscompounds.org) website.

## Victory Band brings music therapy to veterans

The Victory Band, which helps military veterans cope with illnesses, will perform at 1 p.m. Monday, March 3, in the atrium at the Detroit VA Healthcare System, 4646 John R, Detroit.

The band was formed out of a need for music therapy to aid veterans in the Psychosocial Rehabilitation and Recovery Center at the facility.

"In this unique program, we are focused on recovery and rehabilitation, not just treatment," said Michelle Abela, a psychologist at the De-

troit VA Healthcare System. "We see everything from PTSD to severe depression and schizophrenia. Eighteen months ago, as staff was brainstorming ways we could help our patients, a veteran in the program suggested that we start a band. We had been thinking about ways to incorporate music into our program and we knew that music can offer a number of benefits, so this seemed like a good concept."

Steve Munafo and Matt Thomas supplied

the instruments and the music through their Jam for Vets project. They also offered to teach some of the patients how to play the instruments.

Abela said music can help patients with their coping skills, stress management, expressing feelings, leadership and team building.
